RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely **Jayoti Vidyapeeth Womens University Jaipur, Plot No.-NA, Street No.-00, Village- Jharna, Post Office- Vedaant Gyan Valley Jharna, Tehsil/Taluka- Mojmabad, Town/City- Jaipur, District- Jaipur-303122, Rajasthan** for conducting of **M.Ed. Course** of two years duration with annual intake of 50 (One Unit) vide Order File No. NRC/NCTE/Recognition/M.Ed./2016/156668-74 dated 26.08.2016 from the academic session 2017-2018.

2. **AND WHEREAS**, the PAR matter was considered by WRC in its 416th Meeting held on 20th - 21st March 2025, wherein the Committee decided as under:

“As per provisions contained in Section 12 (k) of the NCTE Act, 1993, it is mandatory for all the recognized Teacher Education Institutions (TEIs) to fill the Performance Appraisal Report (PAR).”

In pursuance to the decision taken by the Council in its 61st General Body Meeting held on 5th August 2024, a public notice dated 09.09.2024 was issued inviting online applications for filling Performance Appraisal Report (PAR) for the academic session 2021-22 and 2022-23 on the online NCTE portal. The last date of submission of PAR was 10.11.2024 which was extended to 10.12.2024 and further extended to 31.12.2024.

In View of the above facts and decision taken by the Western Regional Committee, you are hereby directed to Show Cause Notice.”

Accordingly, Show Cause Notice was issued to the institution through online mode dated 09.04.2025.

3. **AND WHEREAS**, the matter of institutions (including this institution), which have not filled PAR/not submitted reply to the show cause notices/ reply to the show cause notices received but reply not accepted was considered by WRC in its 421st Meeting held on 05th -07th May 2025, wherein the Committee decided that recognition to M.Ed. Course be withdrawn for non-submission of reply to the Show Cause Notice.

Accordingly, as per decision of the Committee withdrawal order was issued to the institution vide Order File No. NCTE/2025/WRC/PAR/ORDER/NRCAPP-10437/2133-2138 dated 14.05.2025.

4. **AND WHEREAS**, being aggrieved with the withdrawal Order dated 14.05.2025, the institution has filed W.P. (C) No.5275/2026 before the Hon'ble High Court of Delhi At New Delhi and the Hon'ble High Court has passed an Order dated 12.05.2026 with the following directions:

“...3. Mr. Kapoor, learned counsel accepts notice on behalf of the respondents.

4. He states that the present matter is covered by the judgment of a Coordinate Bench of this Court passed in a batch of similar petitions, one of them being Teachers Training College Mirza v. National Council for Teacher Education & Anr., W.P.(C) 5369/2025, order dated 15.12.2025.

5. Accordingly, the present writ petition is allowed, holding that the directions passed by the Coordinate Bench in paragraphs No. 12 to 16 in the judgment of Teachers Training College Mirza (supra) shall apply to the petitioner, including the direction to permit the petitioner to participate in the counselling session for the academic session 2025-26.

6. The above directions are subject to verification by the National Council for Teacher Education (NCTE).

7. The writ petition is disposed of in aforesaid terms.”

5. **AND WHEREAS**, the matter was considered by WRC in its 460th (Part-III) Meeting held on 13th -15th May, 2026, wherein the Committee decided as under:

“As a part of compliance of directions passed vide order dated 15.12.2025 in W.P. No. 5369/2025 titled as Teachers training college Mirza vs. National Council for Teacher Education & Anr. by the Hon'ble High Court of Delhi, the related matter was considered by WRC in its 445th (Part-1) meeting of WRC held on 07th-10th January 2026. As per decision of WRC, restoration order have been issued to various teacher education institutions (TEIs).

In reference to order dated 15.12.2025 passed by Hon'ble High Court of Delhi (on PAR batch matters), the Hon'ble Court has passed orders (on similar case) with the following directions:

“..1. The learned counsels appearing on behalf of the petitioners urges the court that the present petitions may also be disposed of in terms of the order passed by this court of 15.12.2025 in batch of petitions, lead case being W.P. No. 5369/2025 titled as Teacher Training College Mirza, vs. National Council for Teacher Education & Anr. 3 In view of the above, the present petitions along with pending applications are disposed of in terms of order dated 15.12.2025, the benefit of which shall also ensure to the present petitioners...”


