**WITHDRAWAL ORDER**

WHEREAS, WRC, NCTE had granted permission to the institution namely **SCHOOL OF STUDIES IN PHYSICAL EDUCATION AND SPORTS STUDIES, JIWAJI UNIVERSITY, GWALIOR, MADHYA PRADESH** vide order no. WRC/5-6/2k/169-174 dt. 10.01.2001 for conducting the **B.P.Ed.** course with an annual intake of 50 seats.

AND WHEREAS, the revised recognition order was issued to the institution namely **SCHOOL OF STUDIES IN PHYSICAL EDUCATION, JIWAJI UNIVERSITY, GWALIOR, MADHYA PRADESH** vide order no. WRC/OAPW0496/214010/Revised order {M.P.}/2015/136111 dt. 20.05.2015 for **B.P.Ed.** course of two years duration with an annual intake of 100 students from the academic session 2015-16.

AND WHEREAS, As per decision of WRC in its 255<sup>th</sup> meeting Show Cause Notice dt. 01.02.2017 was issue to the institution on the following grounds:-

- Staff Profile for the session 2015-16 duly approved by the Affiliating Body.
- Originally notarized CLU/NEC/BP and Building Completion Certificate."

AND WHEREAS, the institution has submitted reply on 21.02.2017. was considered by the WRC in its 311<sup>th</sup> meeting held from September 25-27, 2019 and the Committee decided as under:-

"The revised recognition order was issued to the institution vide order dated 20/05/2015. The SCN was issued to the institution on 01/02/2017. The institution has submitted reply of SCN on 21/02/2017.

On perusal of the reply of the institution the committee observed that:

- The University has submitted staff list signed by HOD for B.P.Ed. & M.P.Ed. course, One Director & 8 Assistant Professor which is not as per NCTE Regulations, 2014.
- The University has not submitted NEC issued by the competent authority.
- The institution has not submitted land Use certificate issued by the competent authority.
- The institution has not submitted building plan approved by the competent authority.
- The institution has not submitted BCC issued by the competent authority.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee hereby withdraws recognition of **SCHOOL OF STUDIES IN PHYSICAL EDUCATION, JIWAJI UNIVERSITY, GWALIOR, MADHYA PRADESH** granted for **B.P.Ed** Programme on the grounds mentioned above from the end of the academic session next following the date of communication of the said order.
