CONTINUED ORDER

WHEREAS, recognition was granted to the institution namely, **SWAMI VIVEKANAND MAHAVIDYALAYA, ATER M.P.E.B. COLONY, RADHAKRISHANAN BUILDING, SATAI ROAD, CHHATARPUR MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting **B.ED.** course of one year duration with an annual intake of 100 (two basic Units of 50 students each) vide order No. WRC/5-6/101st/2008/dated 28.01.2008.

AND WHEREAS, the revised recognition order was issued to **SWAMI VIVEKANAND MAHAVIDYALAYA, ATER M.P.E.B. COLONY, RADHAKRISHANAN BUILDING, SATAI ROAD, CHHATARPUR MADHYA PRADESH** vide order No. WRC/ APP05950/223664/2015 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution has not submitted compliance of the condition maintained in revise order"

AND WHEREAS, a Show cause notice was issued to the institution on 12.05.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Original Staff Profile (1 Principal/HOD+15-Faculties) for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 310th Meeting held on August 19-21, 2019 and the Committee decided that... "The compliance letter was issued to the institution vide letter dated 12/05/2017 and reply received on 21/06/2017.

Moreover, the staff profile for approved intake & Building Completion Certificate are not submitted in original. Date of appointment of staff are not mentioned in the staff list. CLU, NEC are also not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order"

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, after perusal of the memorandum of appeal, affidavit, documents on records and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter after the appellant institution submits required documents within 15 days of the issue of appeal order.

AND WHEREAS, the matter was placed in 317th Meeting held on 28th and 30th September 2020 and the Committee decided ... "The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 5585/2020 and CM No. 2017178/2020 and noted that as per the direction of the Hon'ble Court, the name of this institution has been updated on the website of NCTE and also the letter to the State Government has been sent.

The WRC examined the reply submitted by the institution and observed the following: -

- The appointed staff is not qualified as per NCTE Regulations 2014, as amended vide notification dated 09th June 2017.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act"

AND WHEREAS, the Final Show Cause order was issued to the institution on 15.10.2020 and reply received on 21.10.2020.

AND WHEREAS, the matter was considered by WRC in its 324th Meeting held on 23rd and 24th and 31st December 2020 and WRC decided (Ref: Sl. No. 15, Page No. 14-15 of 324th WRC Minutes) as under: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution has submitted all required documents which were considered by the Committee and found fit the case for issuance of Final Recognition order for two units.

In view of above, the Committee decided as under:

Recognition of the institution be continued for the B.Ed. programme with an intake of two units of 50 students each."

NOW THEREFORE, the recognition of **SWAMI VIVEKANAND MAHAVIDYALAYA, ATER M.P.E.B. COLONY, RADHAKRISHANAN BUILDING, SATAI ROAD, CHHATARPUR MADHYA PRADESH** for conducting B.Ed. course with an annual intake of 100 (two basic Units of 50 students each) continued from the date of issued of this order.
