

ORDER OF WITHDRAWAL OF RECOGNITION

{Under sub-section (1) of section 17 of the National Council for Teacher Education Act, 1993}

(To be published in Gazette of India)

WHEREAS, on 11.04.2007, Late Shri Rajendra Katare Sewa Samiti Shahdol (a society registered under Madhya Pradesh Societies Registrickaran Adhinyam, 1973) had applied under section 14 of the National Council for Teacher Education Act, 1993 (Here-in-after called "NCTE Act") for grant of recognition to Shri Rajendra Katare Shiksha Mahavidyalaya, Katare Complex, Shankar Talkies Rd., Shahdol, (MP) (APW05874/223640) (Here-in-after called "the institution") to start B.Ed. programme with annual intake of 100.

AND WHEREAS, the Western Regional Committee of NCTE (Herein after called "WRC") in its 100th meeting considered the requisite documents submitted by the institution and the input of the Visiting Team dated 07.08.2007 and issued the order dated 01.01.2008 U/R 7(9) followed by order dated 17.03.2008 U/R 7(11) of NCTE (Recognition, Norms & Procedure) Regulations, 2007;

AND WHEREAS, NCTE Hqrs., in compliance of order of Hon'ble High Court at Jabalpur dated 30.04.2008 in W.P. 5168/2008, constituted the four member committee which scrutinized the entire record and submitted its report to the Chairperson, NCTE who approved the same and declared that the institution was duly recognized from academic session, 2008-09;

AND WHEREAS, the WRC in its 121st meeting held on July 07-08, 2009 decided to refuse the recognition as the institution had admitted students in academic session 2007-08 without obtaining the unconditional recognition but NCTE Hqrs., vide appellate order dated 08.11.2009, ordered that though the institution was not entitled to recognition for the academic session 2007-08 but it will be a recognized institution from academic session, 2008-09;

AND WHEREAS, the WRC in its 162nd meeting considered the report of the Commissioner, Higher Education, and, being of the opinion that financial resources, accommodation and faculty of the institution were not as per NCTE Norms & Standards, issued the show cause notice dated 18.01.2014 demanding following documents to ascertain whether the institution has adequate financial resources, accommodation and qualified staff as per NCTE Regulations;

- i. Approved Building Plan from Municipal/Panchayat authorities,
- ii. Land Use Certificate from the SDO, Shahdol,
- iii. Affidavit as to land and building in prescribed form,
- iv. Building Completion Certificate in prescribed form,
- v. Original FDRs for Rs. 5.00 lacs and Rs. 3.00 lacs,
- vi. Non-encumbrance certificate from Tehsildar/SDO,
- vii. Proof the faculty was appointed on the recommendation of the Selection Committee constituted by the affiliating university,
- viii. Proof the payment of salary to staff was being made as per pay scale of UGC/University and through bank payment.



AND WHEREAS, the institution demanded the copies of prescribed forms of NCTE which were supplied on 22.05.2014 in compliance of directions of WRC in its 205th meeting yet the institution failed to submit its reply along with the requisite documents stated above.


NOW, THEREFORE, in exercise of powers u/s 17(1) of the NCTE Act, the WRC, in its 279th meeting held on August 10-11, 2017, considered the entire record and decided to withdraw the recognition of the institution from the end of the academic session 2017-18 for contravening the provisions of NCTE Act, its Rules and Regulations, revised from time to time and it did not have adequate financial resources, accommodation and qualified staff.

Hence, this order is issued under the directions of WRC.

Further, if the institution is not satisfied by the order, it may prefer an online appeal to NCTE, Hans Bhawan, Wing II, Bahadur Shah Zafar Marg, Near ITO, New-Delhi 110002 u/s 18 of the NCTE Act within 60 days of the issue of this order. The guidelines for filing the appeal may be downloaded from the website of NCTE.
