RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, SHRI RAJENDRA KATARE SHIKSHA MAHAVIDYALAYA, PLOT NO- 61, SHAHDOL- 484116, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide Formal order dated 01.01.2008 & 17.03.2008 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 19.01.2015 & 06.02.2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 08.10.2015

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on 12.02.2016 and the reply of Deficiency Letter was received in NCTE HQRs. on 16.03.2016.

AND WHEREAS, the VTR (deficiency letter & Institution reply received in WRO from Hqrs) along with file of the institution were received from NCTE Hqrs. in WRO on 12.01.2016.

AND WHEREAS, the Show Cause Notice of compliance issued on 13.12.2016 and reply of compliance received on 11.01.2017.

AND WHEREAS, the letter received from legal section dated 27.03.2017 W.P. No. 1673/2015 filed by Ramesh Kumar Pandey, Distt. Rewa, M.P.

AND WHEREAS, the matter was placed in 279th Meeting held on August 10 - 11, 2017 of WRC and the Committee decided that "...A scrutiny of the file shows that the WRC in its 162nd meeting decided that the Show Cause Notice be issued under Section -17 regarding.

1. Approved building plan issued by Municipal Corporation or Gram Panchayat.
2. Notarized copy of change of Land Use Certificate (Diversion order from Tehsildar/SDO Collector).
3. Affidavit in the prescribed form on Rs. 100/- stamp paper duly attested by Oath Commissioner or Notary Public as required under clause 7 (1) of NCTE, Regulation, 2009.
4. Original fixed deposit receipt of Rs. 5.00 Lakh of Nationalized Bank towards Endowment Fund and Rs. 3.00 Lakh of Nationalized Bank towards reserve Fund.
5. Building Completion Certificate. The same should be submitted in the enclosed proforma.
6. Non-encumbrance certificate from Tehsildar/SDO.
7. The academic staff of the institution (including part -time) is not being paid salary and scale prescribed by the UGC/University from time to time; through account payee cheque or as per advice into the bank account of employee specially opened for the purpose. The supporting staff is not being paid as per the UGC/State Government/Central Government pay scale structure.
8. The appointment of the academic staff has not been made on the basis of recommendation of the Selection Committee constituted as per the policy of the UGC/Affiliating University.

The institute did not submit any reply to the office. Consequently a clarification was issued on the same issue but no reply was received against the points mentioned in the Show Cause Notice.

Hence Recognition is withdrawn from the session 2018-2019.

FDRs, if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 18.08.2017. The institution filed a appeal to the appellate authority Hqrs. no. 12002 dated 16.10.2017. Regulatory file sent to Hqrs. on 13.12.2017.


AND WHEREAS, the appeal order dated 13.02.2018 the Council hereby remands back the case of Shri Rajendra Katere Shiksha Mahavidyalaya, Plot No.-61, Shahdol, Madhya Pradesh, to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 292nd Meeting held on May 15 - 17, 2018 of WRC and the Committee decided that "...The case file was seen. This is a case of appeal. Appellate Authority vide order dated 13.02.2018 has remanded the case to WRC. As directed by the Appeal Committee, the documents submitted by the institution to the Appeal Committee on 20.12.2017 were examined. The institution has enclosed a staff profile of 1 Principal and 16 faculty members, who are qualified and approved by the competent authority. It has also submitted a Building Completion Certificate from the PWD.

Hence, Recognition is restored.

NOW THEREFORE, the recognition of SHRI RAJENDRA KATARE SHIKSHA MAHAVIDHYALAYA, PLOT NO- 61, SHAHDOL- 484116, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is herby revived.


