Restoration Order

Whereas, recognition was granted to **SHRAMDHAM ARTS AND COMMERCE COLLEGE, POST-KYMORE, KATNI-483880, MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting B.Ed. course vide order dated **26.09.2005** with an annual intake of 100 students.

AND WHEREAS, the recognition of B.Ed. course of the said institution was refused vide order no. WRC/MP/APW00608/223146/2009/53783 dated 13.04.2009.

AND WHEREAS, the institution had preferred an appeal against the refusal order. The Appeal Committee vide order dated 13.08.2009 disposed appeal with the direction "the Council felt the orders issued by WRC for refusal of recognition under section 14(3) (b) needed modification to the extent that recognition of the institution be withdrawn under section 17 of the NCTE Act, with prospective effect subject to the following conditions:

- The student already admitted, with due observance of affiliation norms/ conditions, be allowed to complete the programme.
- No fresh admission, either backdated or post dated (with reference to any backlog whatsoever), shall be made in the institution subsequent to the date of the withdrawal of NCTE recognition."

AND WHEREAS, the institution filed Writ Petition No. 4790/2014 dated 05.11.2014 and the Hon'ble High Court of Madhya Pradesh Principal seat at Jabalpur passed the order dated 05.11.2014 : "We are of the considered view that as the impugned action was taken based on a subsequent Regulation which came into force in the year 2007, the action of the respondents in cancelling the approval without granting opportunities to the petitioner to rectify the defect if any found lacking is unsustainable. Accordingly this petition is allowed. Orders impugned annexures P-1 and P-2 are quashed and the matter is remanded back to the appellate committee to reconsider the matter in the light of the observations made by the Coordinate Bench of this Court in W.P.No. 14743/10 as reproduced in para-11. The action be taken by the respondents appellate authority well in time before next commencing session 2015-16.

With the aforesaid, this petition stands allowed and disposed of."

AND WHEREAS, the institution again preferred an appeal before the Appeal Committee. The Appeal Committee vide order dated 07-09-2015 remanded the case of Shramdham Arts and commerce college, Katni, M.P., to the WRC, NCTE, for necessary action as indicated in the appeal order."

AND WHEREAS, the matter was placed in **232<sup>nd</sup> meeting held on September 16-17, 2015** of WRC and the Committee decided that "...The appellate authority vide order dated 07.09.2015 has taken the following decision:- "if necessary an inspection may be conducted to identify the adequacy of instructional resources for conducting B.Ed."

The WRC decided to send a VT, which should be asked to submit a comprehensive report on the infrastructural and instructional facilities. The visiting team should also keep in mind the observations of the Hon'ble High Court regarding the applicability of regulations existing in the year 2005."

AND WHEREAS, the Inspection letter sent to Institution & VT members on 06.10.2015, inspection conducted by VT members on 16.10.2015 and the VT report/letter received in WRC on 20.10.2015.

AND WHEREAS, the matter was placed in 234<sup>th</sup> Meeting held on November 03-05, 2015 of WRC and Committee decided that "...The case file was seen. The institution has applied for the B.Ed. course on 26.12.2003. Recognition was granted on 26.09.2005. Subsequently, Refusal order was issued on 13.04.2009. The Society went in appeal and also filed a Writ Petition. The Appellate Authority vide order dated 07.09.2015 has said, "...if necessary an inspection may be conducted to identify the adequacy of instructional resources for conducting B.Ed.". Accordingly, an inspection was conducted on 16.10.2015.

VT report was perused and the CD was viewed. The CD shows an adequate building with sufficient infrastructural and instructional building as per the norms prevalent at that time. The VT has recommended the case.

**Hence, Recognition is restored.**

However, the attention of the institution is drawn to the requirement of fulfilling the instructional facilities// as per NCTE Regulations, 2014."

Now therefore, the recognition of **SHRAMDHAM ARTS AND COMMERCE COLLEGE, POST-KYMORE, KATNI-483880, MADHYA PRADESH** for conducting B.Ed. course of 2 year duration with an annual intake of 100 seats (two basic units of 50 students each) is hereby restored.
