WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, **AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILL-DHANORA, PLOT NO. 28, DHANORA, DURG-CHHATTISGARH** vide Order No. WRC/5-6/12.1st/2009/57505-57510 dated 13.07.2009 for **B.Ed. (CO-ED)** course of one year duration with an annual intake of 100 students from the academic session 2009-2010.

WHEREAS, the revised recognition Order was issued to the institution namely, **AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILL-DHANORA, PLOT NO. 28, DHANORA, DURG, CHHATTISGARH** vide order No. WRC/APW08052/723170/B.Ed. (Revised Order)/2015/143874 dt. 31.05.2015 for conducting **B.Ed.** programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter was considered by the WRC in its 285th meeting held on 19-21 December, 2017 and the Committee decided as under:-

"...In response to Revised Recognition order dated 31.05.2015, the institution was directed to submit documents related to staff, funds and Building Completion Certificate.

The institution vide letter dated 30.10.2015 has submitted a list of 1+15 faculty members, which is not approved. Lecturer at S.No.15 is not qualified as he does not have M.P.Ed. degree.

Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer should be submitted and FDR of Rs.12.00 lakhs (in joint name) should be submitted in original).

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

AND WHEREAS, Show Cause Notice was issued to the institution on 01.01.2018. The institution has submitted reply vide letter dt. 19.02.2018 received on 23.02.2018. The matter was considered by the WRC in its 312th meeting held on 27th to 29th January, 2020 and the Committee decided as under:-

"On careful perusal of the file of the institution and other related documents, the Committee observed as under :-

- Revised recognition order was issued to the institution on 31.05.2015 with certain conditions. The compliance to the Revised recognition order was not received.
- The Show Cause Notice dated 01.01.2018 was issued to the institution on account of non compliance to the revised recognition order.
- No reply / required documents have been received from the institution.

The Committee resolved to give last opportunity to the institution to submit compliance to the Revised Recognition Order as per NCTE Regulations 2014, as amended vide Notification dated 09th June 2017 within 30 days."

AND WHEREAS, Show Cause Notice was issued to the institution on 06.02.2020. The institution has submitted reply vide letter dt. 06.03.2020 received on 13.03.2020. The matter was considered by the WRC in its 322nd meeting held on 23rd and 24th November, 2020 and the Committee decided as under:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. This is a RPRO case.
2. As per the decision of WRC in 312th meeting, Final SCN giving last opportunity was issued to the institution vide dated 06th February 2020.
3. The reply to SCN submitted by the institution vide dated 06th March 2020 was considered by WRC and the WRC found that: The institution has submitted the staff list, which is not approved by the affiliating body.

In view of the above, the Committee decided that recognition granted to the institution for B.Ed course be withdrawn from the academic session 2021-2022."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby withdraws recognition of **AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILL-DHANORA, PLOT NO. 28, DHANORA, DURG, CHHATTISGARH** granted for **B.Ed.** course on the grounds mentioned above from the academic session 2021-2022.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
