**RESTORATION ORDER**

**WHEREAS**, recognition was granted to the Institution namely to **AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILLAGE- DHANORA, PLOT NO. 28, DHANORA, DURG, CHHATISGARH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course, with an annual intake of 100 students (Two basic units of 50 students each) vide order No. APW08052/723170/WRC/5-6/121/2009/57505-57510 dated 13-07-2009.

**AND WHEREAS**, Revised Recognition order was issued to **AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILLAGE- DHANORA, PLOT NO. 28, DHANORA, DURG, CHHATISGARH** vide order F.NO. WRC/08052/723170/B.ED. (REVISED ORDER)/2015/143874-143917 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

**AND WHEREAS**, Compliance was not submitted as per regulations 2014.

**AND WHEREAS**, the matter was placed in 285<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that

"...The case file was seen. In response to Revised Recognition order dated 31.05.2015, the institution was directed to submit documents related to staff, funds and Building Completion Certificate.

The institution vide letter dated 30.10.2015 has submitted a list of 1+15 faculty members, which is not approved. Lecturer at S.No.15 is not qualified as he does not have M.P.Ed. degree.

Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer should be submitted and FDR of Rs.12.00 lakhs (in joint name) should be submitted in original).

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

**AND WHEREAS**, a Show Cause notice was issued to the Institution on 01.01.2018 its reply received on 19.02.2018.


**AND WHEREAS**, the matter was placed in 312<sup>th</sup> Meeting held on January 27-29, 2020 of WRC and the Committee decided that.

"... On careful perusal of the file of the institution and other related documents, the Committee observed as under :-

- Revised recognition order was issued to the institution on 31.05.2015 with certain conditions. The compliance to the Revised recognition order was not received.
- The Show Cause Notice dated 01.01.2018 was issued to the institution on account of non compliance to the revised recognition order.
- No reply / required documents have been received from the institution.

The Committee resolved to give last opportunity to the institution to submit compliance to the Revised Recognition Order as per NCTE Regulations 2014, as amended vide Notification dated 09th June 2017 within 30 days."

**AND WHEREAS**, a Show Cause Notice was issued to the Institution on 06.02.2020 and its reply received on 13.03.2020.



**AND WHEREAS**, the matter was placed in 322<sup>th</sup> Meeting held on November 23-24, 2020 of WRC and the Committee decided that.

*"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:*

- *This is a RPRO case.*
- *As per the decision of WRC in 312th meeting, Final SCN giving last opportunity was issued to the institution vide dated 06th February 2020.*
- *The reply to SCN submitted by the institution vide dated 06th March 2020 was considered by WRC and the WRC found that: The institution has submitted the staff list, which is not approved by the affiliating body.*

**In view of the above, the Committee decided that recognition granted to the institution for B.Ed course be withdrawn from the academic session 2021-2022"**

**AND WHEREAS**, a withdrawal order was issued to the institution 11.12.2020.

**AND WHEREAS**, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 11.12.2020. The Appellate Authority passed an order dt. 04.06.2021 confirm the order appealed against.

**AND WHEREAS**, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 10763/2021 dt. 23.09.2021 the operative part is produced here below:-

*"...In view of the fact that the order of withdrawal of recognition, which has been challenged in the present petition, was passed by the Western Regional Committee ["NCTE"] on 11.12.2020, it would take effect only from the end of the academic session 2021-22, in accordance with the second proviso to Section 17 of the NCTE Act, 1993. To the extent that the impugned order of the WRC reflects that the withdrawal order is from academic session 2021-22", it is prima facie contrary to the mandate of the said proviso.*

*Consequently, it is clarified by way of interim relief, that the petitioner is eligible to participate in the counselling and admit students for the academic session 2021-22. The NCTE is directed to reflect the correct status of the petitioner on its website and also communicate the same to the concerned State Government and the petitioner's affiliating university, within one week from today."*

**NOW THEREFORE, recognition of the institution viz AGRASEN COLLEGE, RUN BY AGRASEN EDU. SOCIETY, 655/1, 656/1, VILLAGE- DHANORA, PLOT NO. 28, DHANORA, DURG, CHHATISGARH for B.Ed. course with an annual intake of 100 students (Two basic units of 50 students of each) is hereby restored.**

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
