WRC/APP1666/176th/2012/99091-99097 dated 22.01.2013 to start the B.Ed. course with an annual intake of 100 students.

And WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATION, 2014 was issued to the institution on 21.01.2015 the institution submitted affidavit vide letter dated 06.01.2015

And WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015

The institution vide its letter No. MES/AES/2016/182 .dated 22.01.2016 has requested this office to reduce the intake of 2 units (100 students) to unit (50 students).

And WHEREAS, the matter regarding reduce in intake was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that ".....institution which have requested for reducing intake may be permitted".

Now therefore, the intake of the institution is here by reduce from 2 units (100 students) to 1 unit (50 students) to conduct of B.Ed. course.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.
