Recognition Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **MOTIWALA EDUCATION & WELFARE TRUST'S** has submitted an application (Code No. APW06132/123757) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting **B.ED.(E) (CO-ED)** course with an annual intake of **100** students on **24-Apr-07**.

2. AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government the Committee issued letter of intent under 7(9) of Regulations 2007 vide letter No. WRC/NCTE/2007-2008/40925 dated 31.08.2008.

3. AND WHEREAS, WRC in its 112th Meeting decided that "All the applications under process for B.Ed. course from Maharashtra to be returned as per the NCTE Hqrs direction vide letter No. 49-27/2007/NCTE(N&S)Part/87096 dated 21.11.2008."

4. AND WHEREAS, Institution has submitted an appeal to NCTE, New Delhi (appellate authority) against the above decision and appellate authority reversed the decision of Regional Committee vide letter No. 89-13-A/2009-Appeal/92625 dated 20.03.2009.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition/permission to **MOTIWALA COLLEGE OF EDUCATIONAL SCIENCES, MOTIWALA EDUCATION & WELFARE TRUST, MOTIWALA NAGAR, GANGAPUR SATPUR LINK ROAD, NASHIK-422222, MAHARASHTRA** for conducting **B.ED.(E) (CO-ED)** course of **SEC** of 1 year duration with an annual intake of **100** from the academic session **2008-2009** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations 2007 subject to fulfilling the usual condition of **180 teaching days, affiliation by examining body etc. as per clarification received vide NCTE letter No. 49-27/2007/NCTE (N&S)/89496 dated 31.12.2008.**

6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

9. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

10. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC , affiliating University/Body, the State Government etc, applicable.

11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
