WITHDRAWAL ORDER

WHEREAS, WRC, NCTE had granted permission to the institution namely THE PRESTON COLLEGE, SURVEY NO.1500, 1501, 1502, 1503, VILL. KHURARI BEDA GUNA ROAD MORAR, GWALIOR, MADHYA PRADESH vide order no. WRC/5-6/102 (II)/2008/30846 dt. 19.03.2008 for conducting the M.Ed. course with an annual intake of 40 students.

AND WHEREAS, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 THE PRESTON COLLEGE, SURVEY NO. 1500, 1501, 1502, 1503, VILL. KHURARI BEDA GUNA ROAD MORAR, GWALIOR, MADHYA PRADESH offering M.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

AND WHEREAS, after the receipt of affidavit dt. 08.01.2015 from the institution, a revised recognition order no. WRC/APW04587/225051/M.P./2015/135938-135945 (Revised Order) dt. 20.05.2015 was issued to the institution for conducting M.Ed. course with an annual intake of 50 students (One basic unit) from the academic session 2015-16.

AND WHEREAS, the WRC vide revised recognition order dt. 20.05.2015 was directed to the institution to submit the following documents in compliance of the NCTE Regulation, 2014:-

1. List of teaching staff duly signed/approved by the affiliating body.
2. Duly notarized CLU/NEC/BP and Building Completion Certificate.
3. Proof of maintaining the Endowment fund and Reserve fund as per NCTE regulations, 2014.

AND WHEREAS, the matter regarding compliance by the institution of the condition mentioned in revised recognition order was placed before WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided that "...Show Cause Notice be issued to all such institutions which have not submitted compliance."

AND, WHEREAS, a Show cause notice was issued to the institution on 05.01.2017 for not submitting compliance of Regulation 2014 required faculty staff list for 50 students and infrastructure.

AND WHEREAS, the reply of Show cause notice not submitted by the institution. The matter was placed before the WRC in its 290th meeting held on March 21-23, 2018 and the Committee decided that "...Show Cause Notice was issued to the institution on 05.01.2017. The institution has not replied so far. Hence, Recognition is withdrawn from the end of the next academic session."

NOW THEREFORE, the permission of PRESTON COLLEGE, SURVEY NO.1500, 1501, 1502, 1503, VILL. KHURARI BEDA GUNA ROAD MORAR, GWALIOR, MADHYA PRADESH for conducting M.Ed. programme of 2 year duration with an annual intake of 50 students (One basic unit) is hereby withdrawn from the academic session 2018-19, in terms of section 17(1) of the NCTE Act, 1993.
