Whereas, the recognition was granted to the institution namely ASHADEEP MISHRA ADHYAPAN NANDIR, JAGDISIBHAI DAHYABHAI PATEL, AT./PO-, CHANDRALA, C/O.- ASHIRVAD FARM, TA-GANDHI NAGAR, GUJARAT (APW02928/322330) for P.T.C. Course vide order No.WRC/5-6/90/2006/ dated 28-10-2006 in a rented premises (as per record).

And whereas, a Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 17.01.2012 inter-alia informing the institution about the provision of the regulations and compliance of shifting of the institution in its own premises from the rented premises where the recognition was granted.

And whereas, the institution did not submit reply in compliance of the show cause notice dated 17.01.2012 even after expiry of the time limit mentioned therein.


And whereas, the matter was placed before the WRC in its 174th Meeting held on 19th -21st, Nov. 2012, and the Committee decided to withdraw the recognition on the following grounds :-

- *Notice under Section 17 had been issued to the institution on 17.01.2012. The institution has not replied to the notice till date. Hence recognition is Withdrawn from the academic session next to end of the date of the withdrawal order.*

Now therefore, in exercise of powers vested under section 17(1) of the NCTE Act, 1993, the recognition of ASHADEEP MISHRA ADHYAPAN NANDIR, JAGDISIBHAI DAHYABHAI PATEL, AT./PO-, CHANDRALA, C/O.- ASHIRVAD FARM, TA-GANDHI NAGAR, GUJARAT for P.T.C. course is hereby withdrawn from the end of the academic session next following the date of the withdrawal order.


