WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 BHAGWAN MAHAVEER EDUCATION FOUNDATION TRUST, PLOT NO.149, B/H HEENA BUNGALOWS, NEAR ASHIRWAD BUNGALOWS, BHARTHANA VESU, DIST. SURAT-395007, GUJARAT has submitted an application (Code No.- APW04251/322189(ADDL)) to the Western Regional Committee of NCTE for grant of recognition/permission for permission for Additional intake in existing P.T.C. course with an annual intake of 100 students on 20-12-2006 .

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the ELE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants permission to BHAGWAN MAHAVEER EDUCATION FOUNDATION TRUST, PLOT NO.149, B/H HEENA BUNGALOWS, NEAR ASHIRWAD BUNGALOWS, BHARTHANA VESU, DIST. SURAT-395007, GUJARAT for Additional intake of 100 students in the existing P.T.C. course of ELE of 2 year duration with an annual additional intake of 100(ELE) from the academic session 2009-2010 under clause 7(11) of NCTE( Recognition Norms & Procedure ) Regulation 2007. With this the total approved intake for the-P.T.C. course to the institution BHAGAVAN MAHAVEER EDUCATION FOUNDATION, becomes 150.

- I. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into joint account to be operated along with an officer of the Western Regional Committee.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
  - IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.


