ORDER

WHEREAS, in terms of Section 14/15(3)(a) of NCTE Act, 1993, the institution namely "Bhagavan Mahaveer Education Foundation, Shree Bhartimaiya Vidyasankul, Opp. Vriddhashram, Behind Rajhans, Vesu Road, Surat, Gujarat- 395007" was granted recognition/permission for P.T.C. course two years duration with additional intake of 100, thus total approved intake 150 from the academic session 2009-2010 vide Order No. WRC/5-6/109th/2008/47934-47940 dated 29.10.2008/11.12.2008 followed by Corrigendum vide order No. WRC/APW04251/322189(addl.)/2009/56765-56772 dated 15.06.2009/22.06.2009 issued to Bhagavan Mahaveer Education Foundation, Shree Bhartimaiya Vidyasankul, Opp. Vriddhashram, Behind Rajhans, Vesu Road, Surat, Gujarat- 395007 to read the total annual intake of P.T.C. course 200 students instead of 150 as mentioned in the recognition/permission order dated 11.12.2008.

2. **AND WHEREAS**, a proposal vide letter dated 11.06.2025 was received from Bhagwan Mahavir University in the matter of merger of their three constituent Colleges/institutions conducting D.El.Ed. and C.P.Ed. courses under Bhagavan Mahaveer Education Foundation transferred as constitute colleges/institutions of Bhagwan Mahavir University, Surat together with change of affiliating body from Gujarat State Examination Board to Bhagwan Mahavir University in respect of C.P.Ed. (Co-Ed) course and P.T.C. (D.El.Ed.) courses respectively.

3. **AND WHEREAS**, subsequently, the institution/university has approached the Hon'ble Delhi High Court in this regard and Hon'ble court passed order dated 29.01.2026 in W.P.(C) 1209/2026 and W.P. (C) 1063/2026 with the following directions: -

"1. These are writ petitions bearing No. W.P.(C) 1209/2026 and W.P.(C) 1063/2026 filed under Article 226 of the Constitution of India seeking the following prayers in respectively: -

"(i). issue a writ of mandamus or any other suitable writ or order or direction to respondents to decide petitioner's application for change of affiliating body from Gujarat State Examination board to Bhagwan Mahavir University in respect of C.P.Ed (Co-Ed) Course; and/or

(ii). issue a writ of mandamus or any other suitable writ or order directing respondents to change the affiliating body of petitioner institution from Gujarat State Examination Board to Bhagwan Mahavir University in respect of C.P.Ed (Co-Ed) course with consequential direction to update the name of affiliating university on their official website in the list of recognized institutions maintained by respondents;

“(i). Issue a writ of mandamus or any other suitable writ or order or direction to respondents to decide petitioner's application for change of affiliating body from Gujarat State Examination board to Bhagvan Mahavir University in respect of PTC (D.El.Ed) Course; and/or

(ii). Issue a writ of mandamus or any other suitable writ or order directing respondents to change the affiliating body of petitioner institution from Gujarat State Examination Board to Bhagvan Mahavir University in respect of PTC (D.El.Ed) course with consequential direction to update the name of affiliating university on their official website in the list of recognized institutions maintained by respondents;”

2. Ms. Malhotra, learned counsel for the respondents, on instructions, states that the application of the petitioners shall be decided within 4 weeks from today keeping in view the requisite Act and extant rules/regulations.

3. Needless to say, in case the petitioner is aggrieved, the petitioner will be at liberty to file/revive the petitions.

4. The petitions are disposed of in the aforesaid terms.”

4. **AND WHEREAS**, the aforesaid matter in detail was considered by WRC in its 449th meeting held on 02nd to 05th February 2026, together with Court Order dated 29.01.2026 in W.P.(C) 1209/2026 and W.P.(C) 1063/2026 passed by Hon'ble High Court of Delhi, wherein the Committee decided as under:

“The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- *The institution viz. BHAGWAN MAHAVEER EDUCATION FOUNDATION TRUST, PLOT NO.149, B/H HEENA BUNGALOWS, NEAR ASHIRWAD BUNGALOWS, BHARTHANA VESU, DIST. SURAT- 395007, GUJARAT was granted recognition/permission to P.T.C. Course with additional intake of 100 and total approved intake 150 from the academic session 2009-2010 vide order dated 11.12.2008.*
- *Subsequently, Corrigendum dated 22.06.2009 was issued to Institution viz. BHAGWAN MAHAVEER EDUCATION FOUNDATION, SHREE BHARTIMAIYA VIDYASANKUL, OPP. VRINDHASHRAM, BEHIND RAJHANS, VESU ROAD, SURAT, GUJARAT to read the total annual intake of P.T.C. course 200 students instead of 150 as mentioned in the recognition/permission order dated 11.12.2008.*
- *The Registrar, Bhagwan Mahavir University, VIP Road, Surat, Gujarat- 395007 has submitted an application vide letter dated 11.06.2025 received in WRC on 09.07.2025 enclosing copies of following documents:*

- *The Gujarat Government Gazette Extraordinary (The Gujarat Private Universities Act, 2009) published dated July 7, 2009.*
- *Notification dated 20.09.2019 issued by Education Department, Govt. of Gujarat (The Gujarat Private Universities (Amendment) Act, 2019 - Appointed date 29th September, 2019 as the said Act shall come into force.*
- *Notification dated 20.09.2019 issued by Education Department, Govt. of Gujarat (The Gujarat Private Universities (Second Amendment) Act, 2019 published in The Gujarat Government Gazette Extraordinary dated October 1, 2019 - Appointed date 25th September, 2019 as the said Act shall come into force.*
- *Amendment of Gujarat Private Universities Act, 2009 (Part IV Acts of Gujarat Legislature and Ordinances promulgated and Regulations made by the Governor) published in The Gujarat Government Gazette Extraordinary dated August 20, 2019, wherein at Section 2 titled (Amendment of Schedule of Guj. 8 of 2009) at Sr. No.32., the name of Bhagwan Mahavir University, Surat and Sponsoring Body - Bhagwan Mahavir Education Foundation, Survey No.149, VIP Road, Bharthana- Vesu Road, Surat- 395007 are mentioned.*
- *Notification dated 31.07.2020 issued by Education Department, Govt. of Gujarat (The Gujarat Private Universities Act, 2009 published in The Gujarat Government Gazette Extraordinary dated August 20, 2020 - Approval of First Ordinance of the Bhagwan Mahavir University, Surat by the Governor of Gujarat, wherein at Chapter-4, Sr.No.18 the name college (Bhagwan Mahavir PTC) is mentioned to be run by the University and courses be started from Academic Year 2020-21.*
- *In terms of Section 3 (5) titled "Establishment and Incorporation of Universities" of The Gujarat Government Gazette Extraordinary (The Gujarat Private Universities Act, 2009) published dated July 7, 2009, "The constituent colleges and institutions of the Sponsoring Body affiliated to and enjoying the privileges of any University immediately before the commencement of this Act shall cease to be affiliated from that University and shall be deemed to be withdrawn from such privileges from the date of commencement of this Act and shall be deemed to be admitted to the privileges of corresponding University of the respective Sponsoring Body specified in the Schedule and all such colleges and institutions shall be the constituents colleges, and institutions of that University."*

Further, the Committee noted that in the matter of change of Affiliating Body, the institution filed writ petition W.P.(C) 1063/2026 and W.P.(C) 1209/2026 in the Hon'ble High Court of Delhi and as communicated by NCTE Standing Counsel vide E-mail dated 01.02.2026 together with Order dated 29.01.2026 passed by Hon'ble Court, the petitions

are disposed of with the instructions that the application of the petitioners shall be decided within 4 weeks from today keeping in view the requisite Act and extant rules regulations.

In view of the above, the Committee decided as under:

In pursuance of Gazette Notifications issued by Govt. of Gujarat as mentioned above and subsequent directions of Hon'ble Court, the institution viz. BHAGAVAN MAHAVEER EDUCATION FOUNDATION (APW04251/322189 (ADDL.) for P.T.C. Course with approved intake of 200 be permitted as the Constituents of Bhagwan Mahavir University vis-à-vis affiliating body. All concerned be intimated accordingly."

5. **NOW THEREFORE**, in pursuance of above decision of WRC, Bhagavan Mahaveer Education Foundation, Shree Bhartimaiya Vidyasankul, Opp. Vriddhashram, Behind Rajhans, Vesu Road, Surat, Gujarat- 395007, is hereby permitted as the Constituent Unit of Bhagwan Mahavir University, VIP Road, Surat, Gujarat vis- a vis affiliating body.
