Withdrawal Order U/S-17

WHEREAS, recognition was granted to the institution, namely, MANSAROVAR COLLEGE, MANSAROVAR CAMPUS BEHIND HARSIDDHI HOSPITAL, KOLAR ROAD, BHOPAL- 462016 MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course vide order dated 07.04.2005.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 05.02.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 31.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to the institution on 08.08.2016 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure. The institution reply was submitted on dated 26.08.2016.

AND WHEREAS, the matter was placed before the WRC in its 284th meeting held on November 28-29, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 08.08.2016, the institution has not submitted a staff list separately for B.Ed. and M.Ed. courses. Separate lists approved and in original should be submitted.

Secondly, Building Completion Certificate in the format and counter signed by a Govt. Engineer should be submitted and additional FDR of Rs.4.00 lakhs (in joint name) should be submitted in original (Total requirement is 12.00 lakhs).

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 01.12.2017 and the reply was received on 02.01.2018.

AND WHEREAS, the matter was placed before the WRC in its 293rd meeting held on June 12-14, 2018 and the Committee decided that "... Show Cause Notice was issued to the institution on 08.08.2016 and reply received on 26.08.2016. Compliance letter was issued to the institution on 01.12.2017 and reply received on 01.01.2018.


An analysis of the reply shows that Lectures from Sr. No. 5 to 14 do not have the required NET qualification as per NCTE notification published on 09.06.2017. It has not submitted Building Completion Certificate signed by a Govt. Engineer. It has also not submitted additional FDRs for 4 Lakhs.

Hence, Recognition is withdrawn from the session 2018-19. FDRs, if any, be returned."

Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawal from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
