**ORDER**

WHEREAS, in terms of Section 14(1) of NCTE Act, 1993 recognition was granted to the institution as under:-

(i) MANSAROVER COLLEGE, KHASRA NO.55/8, 56/3, VILLAGE-GADIA, DILKISGANJ, TEHSIL-SEHORE, DISTRICT-SEHORE, MADHYA PRADESH for B.Ed. course of one year from the academic session 2004-2005 with an annual intake of 100 students vide order no. No.WRC/5-6/223211/61/2004/2817 date.07.04.2005.

(ii) Mansarovar College, Mansarovar Campus, Behind Harsiddhi Hospital, Kolar Road, Bhopal-462016, Madhya Pradesh for M.Ed. course of PG of one year from the academic year 2009-2010 with an annual intake of 25(PG) vide order no. WRC/5-6/121th/2009/57744 date: 17.07.2009.

(iii) Mansarovar College, Mansarovar Complex, Opp. Bima Kunj, Kolar Road, Bhopal-462042 Madhya Pradesh for D.Ed.(CO,ED) course of ELE of 2 year duration with an annual intake of 50 (ELE) from academic session 2009-2010 vide order no.WRC/5-6/116th/2008/54232 date.18.04.2009.

2. AND WHEREAS, the letter for affidavit regarding acceptance and compliance of NCTE Regulation, 2014 was issued to the institution on 17.01.2015 and the reply received on 05.02.2015. Revised Recognition order was issued for B.Ed. programme of two basic units of (50 students each) to institution on 31.05.2015 and Revised Recognition order was issued for M.Ed. programme of one basic unit of (50 students) to institution on 20.05.2015.

3. AND WHEREAS, as per decision of WRC Show Cause Notice was issued to the institution on 27.12.2022. and shifting order No. NCTE/WRC/APW00680 /223211(B.Ed.)/ APW07423/ 225140(M.Ed.)/ APW06098/222320(D.El.Ed.)/368th Meeting/2022/221411 Shifting permitted from Masarovar College, Mansarovar Campus Hospital Kolar Road, Bhopal, Madhya Pradesh-462016 to Mansarovar College, Khasra No. 55/8, 56/3, Vill-Gadia, Dilkisganj, Tahsil/District-Sehore, Madhya Pradesh was issued to the institution on 27.12.2022.

4. AND WHEREAS, the institution has requested vide letter dated 17.05.2025 to this office for changing of the University/Affiliating body and wants to run courses as : Mansarovar Global University at Khasra No.. 55/8, 56/3, Village-Gadia, Tehsil & District-Sehore, Madhya Pradesh.

5. **AND WHEREAS**, the matter was considered in its 459<sup>th</sup> meeting, held on 06<sup>th</sup> to 08<sup>th</sup> May, 2026, the Committee decided as under:

*"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time were carefully considered by the WRC, NCTE and the Committee observed as under:*


- i. *The shifting of the institution to Khasra No. 55/8, 56/3, Village Gadia, Bilkisganj, Tehsil-Sehore, Madhya Pradesh was permitted by WRC in its 368<sup>th</sup> meeting held on 27<sup>th</sup> & 28<sup>th</sup> July, 2022.*
- ii. *The institution has submitted request letter for the change in name of the institution from 'Mansarovar College' to 'Department of Education, Mansarovar Global University', change of affiliating body in respect of B.Ed. and M.Ed. courses from 'Barkatullah University, Bhopal' to 'Mansarovar Global University, Sehore' and change of affiliating body in respect of D.El.Ed. course from Board of Secondary Education, Madhya Pradesh, Bhopal to 'Mansarovar Global University, Sehore'.*
- iii. *The sponsoring society of the institution (Shri Sai Gramothan Samiti) has established a private university under the name of 'Mansarovar Global University' and the institution is located within the premises of the said University.*
- iv. *The institution has submitted copy of letter of permission issued by Madhya Pradesh Private University Regulatory Commission, Bhopal.*
- v. *The institution has enclosed copy of Law Dept. Gazette Notification (Madhya Pradesh Act No.4 of 2018) 'The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Sansodhan Adhinayam, 2017 published vide no.21 dated 11.01.2018. Under Section 2 at Sl.No.30 of Madhya Pradesh Act, the name of sponsoring body (Sri Sai Gramothan Samiti, Mansarovar Campus, Kolar Road, Bhopal) and name of Private University (Mansarovar Global University, Sehore) is mentioned.*
- vi. *The institution has enclosed copy of Higher Education Dept., Govt. of Madhya Pradesh Notification dated 13.08.2018 published in the Madhya Pradesh Gazette vide no.33 dated 17.08.2018 (Ordinance No.50- Bachelor of Education (B.Ed.) 2 Year Degree course), (Ordinance No.52- Diploma in Elementary Education (D.El.Ed.) 2 Year Diploma course), (Ordinance No.55- Degree of Master of Education Regular Course (M.Ed.).*
- vii. *The WRC noted that the institution has submitted all the required documents with regard to change of name and change of affiliating body of the institution.*

**Hence, the WRC decided that the name of the institution be changed from 'Mansarovar College' to 'Department of Education, Mansarovar Global University' and the affiliating body of the institution be changed as constituent of Mansarovar Global University from the date of issue of order.**

**The above decision of WRC be communicated to all concerned."**


