ORDER

WHEREAS, recognition was granted to the institution viz.MANSAROVAR COLLEGE, MANSAROVAR CAMPUS, BEHIND HARSIDDHI HOSPITAL, KOLAR ROAD, BHOPAL-462016, MADHYA PRADESH for B.Ed. course with an intake of 100 from the academic session 2004-2005 vide order No.WRC/5-6/223211/61/2004/2811-2817 dated 07.04.2005 followed by revised order dated 31.05.2015. Permission granted for M.Ed. course with an intake of 25 from the academic year 2009-2010 vide order No.WRC/5-6/121th/2009/57743-57748 dated 17.07.2009 followed by order dated 11.01.2011 for intake of 35 and revised order for intake of 50 vide order dated 20.05.2015. In addition, permission granted for D.Ed course with an intake of 50 (ELE) from academic session 2009-2010 vide order no. WRC/5-6/116th/2008/54232 dated 18.04.2009.

2. **AND WHEREAS**, in matter of compliance of conditions in accordance with the NCTE Regulations, 2014, Show Cause Notice u/s 17 was issued dated 08.08.2016 followed by clarification letter dated 01.12.2017 citing deficiencies to be fulfilled for B.Ed. course and Show Cause Notice u/s 17 was issued dated 31.01.2017 followed by second SCN dated 10.08.2018 citing deficiencies to be fulfilled for M.Ed. course.

3. **AND WHEREAS**, WRC in its 293rd meeting held on 12-14 June, 2018 decided that recognition for B.Ed. course be withdrawn for non-fulfillment of deficiencies by the institution from the academic session 2018-2019. FDRs if any be returned. Accordingly, withdrawal order was issued to the institution dated 03.07.2018.

4. **AND WHEREAS**, WRC in its 294th meeting held on July 4-5, 2018 decided to keep the withdrawal order for B.Ed. course issued dated 03.07.2018 in abeyance.

5. **AND WHEREAS**, the institution had submitted an application dated 29.10.2018 regarding shifting of premises to new location at address: Khasra No.55/8, 56/3, Village-Gadia, Bilkisganj, Tehsil-Schore, District-Schore, Madhya Pradesh.

6. **AND WHEREAS**, WRC in its 310th meeting held on 19-21 August, 2019 decided that visiting team be constituted for inspection of the proposed shifting of premises.

7. **AND WHEREAS**, inspection was conducted on 26-27 September, 2019 at the location proposed for shifting of premises and visiting team report was considered by WRC in its 314th meeting held on 13th-15th and 22nd July 2020, wherein the Committee decided to issue the show cause notice on the following grounds:

- Staff list duly approved by the affiliating body for the existing course(s) not submitted.
- The land of the institution is in two pieces. The institution is required to submit a site plan demarcating the location of both the plots.

Accordingly, Show Cause Notice u/s 17 was issued vide this office letter dated 06.08.2020.

8. **AND WHEREAS**, reply vide letter dated 22.08.2020 submitted by the institution in response to SCN dated 06.08.2020 was considered by WRC in its 345th meeting held on 01st-2nd November, 2021 wherein the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act for B.Ed. programme on the following ground:

- The approval letter issued by the affiliating bodies in respect of all the courses run by the institution to be submitted by the institution.

Accordingly, Show Cause Notice u/s 17 was issued to the institution vide letter dated 09.12.2021.

9. **AND WHEREAS**, latest information/documents along with affidavit has not been received from the institution in response to Show Cause Notice dated 10.08.2018 (for M.Ed. course) issued before submission of shifting application dated 29.10.2018 in the context of compliance on fulfillment of deficiencies mentioned therein.

10. **AND WHEREAS**, being aggrieved, the institution filed W.P(C) 8189/2022 before the Hon'ble High Court of Delhi at New Delhi and the Hon'ble Court disposed of the case vide order dated 24.05.2022, the operative part of which is as under:

"...5. *The Petitioner viz. Mansarovar College is a private unaided self-financing institution imparting education in various teacher training courses such as B.Ed, D.Ed, and M.Ed. The Petitioner-College seeks direction to Respondent-Council for deciding its application filed on 29th October, 2018, in a time bound manner, by way of a speaking order. The above-said application was filed for shifting of the premises which has been pending consideration before Respondent-Council, since then.*

6. *Mr. Animesh Kumar, counsel for Respondents, on instructions, states that the said representation, shall be disposed of within a period of four weeks from today.*

7. *Accordingly, the present petition is disposed of with a direction that the Respondents shall pass a speaking order on the application dated 29th October, 2018, within a period of four weeks from today.*

8. *All rights and contentions of the parties are left open."*

11. **AND WHEREAS**, the matter was considered by WRC in its 368th meeting held on 27th & 28th July 2022, wherein the Committee (as recorded at Item No.20, page-12 & 13 of minutes) decided as under:-

"The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:

Hon'ble court order No.8189/2022, Committee took decision to allow the shifting.

- *Shifting of premises for B.Ed., D.EEd and M.Ed. from Mansarovar College, Mansarovar Campus Hospital Kolar Road, Bhopal, Madhya Pradesh- 462016 to Mansarovar College, Khasra No.55/8, 56/3, Vill-Gadia, Dilkisganj, Tehsil/District-Sehore, Madhya Pradesh is permitted.*

- *Show cause notice for compliance of revised recognition order be issued."*

12. **NOW THEREFORE**, in exercise of the powers vested under Section 14/15 (3) (a) of NCTE Act, 1993, permission under Clause 8(9) of NCTE Regulation, 2014 is hereby granted for change of premises in respect of institution viz. Mansarovar College from the address at Mansarovar Campus,
