RESTORATION ORDER

WHEREAS recognition was granted for P.T.C course with annual intake of 50 students from the academic session 2004-2005 to the institution namely "Smt. S.A. Patel Mahila B.Ed. College, Dr. R.B. Patel PTC College, Modhera Road, Opp. Nirma Factory, Mehsana, Gujarat-384002" vide Order No. WRC/2-32/62/2004/4954 dated 03.08.2004.

2. AND WHEREAS, the matter regarding non-submission of PAR by the institution for the academic session 2022-23 was considered by WRC in its 416th meeting held on 20th March, 2025 and as per decision of the Committee, Show Cause Notice under Section 17(1) of NCTE Act, 1993 vide letter dated 30.03.2025 was issued to the institution.

3. AND WHEREAS, the matter was considered by WRC in its 423rd meeting held on 15th May, 2025 and the Committee decided that the recognition/permission granted to Smt. S.A. Patel Mahila B.Ed. College, Dr. R.B. Patel PTC College, Modhera Road, Opp. Nirma Factory, Mehsana, Gujarat- 384002 as referred above be withdrawn under Section 17 of NCTE Act, 1993 on the grounds/reasons mentioned therein with effect from the academic session 2025-2026.

Accordingly, withdrawal order vide order No. NGTE/2025/WRC/PAR/ORDER/322156/6979-83 dated 16.05.2025 was issued to the institution.

4. AND WHEREAS, the institution filed Writ Petition before the Hon'ble High Court of Delhi at New Delhi having W.P. (C) No. 4462/2026, and the Hon'ble Court passed Order dated 06.04.2026, the operative part of court order is as follows: -

"...5. Accordingly, this writ petition is allowed holding that the directions passed by this Court in paragraphs Nos. 12 to 16 in judgment dated 15.12.2025 will apply to the case of the petitioners, including the direction to permit the petitioners to participate in the counselling for academic session 2026-2027.

6. The respondents shall ensure that the petitioner is permitted to participate in the counselling for academic session 2026-27.

7. The petition stands disposed of along with applications, if any."

5. **AND WHEREAS**, the similar PAR matter and related court direction was considered by WRC in its 460 (Part-III) meeting (Item No. 4, page No. 7 & 8 of meeting) held on 13th - 15th May, 2026 and the Committee decided as under: -


"...In consideration of Orders passed by Hon'ble High Court of Delhi in each case, the Committee directed that all concerned may ensure strict and time-bound compliance with the Court order.

Further, the Committee decided that the compliance on similar court matters be carried out on the above lines after due verification of records by the office of WRC, NCTE."

6. **NOW THEREFORE**, in compliance of directions of Court Order, recognition for P.T.C. course with an annual intake of 50 students in respect of institution viz. "Smt. S.A. Patel Mahila B.Ed. College, Dr. R.B. Patel PTC College, Modhera Road, Opp. Nirma Factory, Mehsana, Gujarat- 384002" is hereby restored.

7. The terms and conditions shall remain unchanged as mentioned in the recognition order dated 03.08.2004.
