ORDER OF CLOSURE

WHEREAS, WRC, NCTE has granted the recognition/permission under section 14(3)(a)/15(3)(a) of the NCTE Act 1993 to the institution namely, **SOU. (CO-ED.)** course of **one-year(s)** duration with an annual intake of **100 students** vide WRC order no. **WRC/5-6/105TH/2008/39056-39061** dated: **18/08/2008**.

2. AND WHEREAS, the revised recognition order was issued to the institution namely **SOU. JAYEE YASHWANTRAO MOHITE SHIKSHAN PRASARAK MANDAL, RETHARE BK, TAL. - KARD, DIST. SATARA, MAHARASHTRA 415108** vide order no. **WRC/APW06125/123755/2015/140311-318** dated: **31.05.2015** for conducting the **B.Ed.** course of two-year(s) duration with an annual intake of 100 students from the academic session **2015-2016**.

3. AND WHEREAS, the **SOU. JAYEE YASHWANTRAO MOHITE SHIKSHAN PRASARAK MANDAL, DR. YASHWANTRAO MOHITE B.ED. COLLEGE, RETHARE BK, TAL. KARAD SATARA MAHARASHTRA** has submitted a request for closing the **B.Ed.** course vide its letter dated: **07.09.2019**.

4. AND WHEREAS, the matter was placed before WRC in its **312th** meeting held on **27th -29th** January 2020, and the Committee decided as under:-

"On perusal of the file of the institution and request for the closure of the programme by the institute / Management, the Committee resolved to accede to the request of the management / institution and decided that the recognition granted to the institution be withdrawn from the end of the academic session and withdrawal order be issued.

Further, the FDRs towards Endowment and Reserve fund, available with NCTE, may be returned / permitted to be encashed only after submission of the following documents:-

- *Resolution of the Society for closure of the programme.*
- *NOC from the affiliating body as well as from the State Government for closure of the programme."*

5. Now therefore, as per the decision of WRC, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993 as amended time to time the Western Regional Committee hereby **withdraws** recognition of **SOU. JAYEE YASHWANTRAO MOHITE SHIKSHAN PRASARAK MANDAL, RETHARE BK, TAL. - KARD, DIST. SATARA, MAHARASHTRA 415108** granted for conducting **B.ED.** course acceding to the request for closure made by the Society/Trust/Institution from the end of the academic session next following the date of communication of this order.

6. Further, the institution is requested to send the documents as required by WRC, in order to enable WRC to send the FDRs of the institution, if any, available with WRC-NCTE.
