ORDER

WHEREAS, the institution, namely, **PRAMOD RAVINDRA DHURI ADHYAPAK MAHAVIDYALAYA SURVEY NO.74, (OLD 376) HISSA N.34 OF VILLAGE SALGOAN, TAL. KUNDAL, DIST. SINDHUDURG, MAHARASTHRA** for B.Ed. course with annual intake of 100 students vide Order No.WRC/5-6/101st/2008/27767-27773 dated **28.01.2008**.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW04706/123577/2015/136742-757 dated **25.05.2015** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic unit of 50 students) from the academic session 2015-2016.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 15.02.2017.

4. AND WHEREAS, in response to the aforesaid show cause notice, reply not submitted by the institution.

5. AND WHEREAS, a letter dated 07.03.2017 & 15.11.2022 received from the institution requesting for reduction of intake from 2 units (100 seats) to 1 unit (50 seats) in B.Ed. course.

6. AND WHEREAS, the matter was placed in 375th meeting held on 18th -19th November 2022 and the Committee decided that:-

"The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

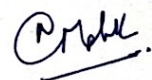
- Initial recognition was granted for B.Ed. course of one year dated 28.01.2008.
- Revised order was issued for B.Ed. course of two years dated 25.05.2015.
- Show cause notice dated 15.02.2017 was issued due to non-compliance of conditions as required under NCTE Regulations, 2014. Reply not submitted.
- The proposal submitted by institution vide letter dated 07.03.2017 & 15.11.2022 for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit).

In view of the above, the Committee decided as under:

The institution be allowed permission for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit) w.e.f. the commencement of academic session 2022-2023. The Affiliating Body/State Government and others be intimated accordingly."

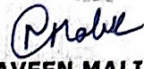

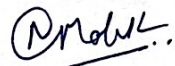
