**RESTORATION ORDER**

**WHEREAS** an application to the Northern Regional Committee of NCTE on 22.06.2015 for grant of Recognition/permission to institution namely **SARVODAYA GIRLS COLLEGE, PLOT NO. 706, STREET NO. NH-113, VILL-NAYA PADARIYA KALINJARA, TEHSIL/TALUKA-BAGIDORA, POST OFFICE-KALINJARA, DIST-BANSWARA-327606, RAJASTHAN** for **D.El.Ed.** course with annual intake of 100 students (2 basic units of 50 students each).

2. **AND WHEREAS**, the matter was placed in 258<sup>th</sup> Meeting of NRC held on October 04-06, 2016 and the Committee decided that

"...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observation was made:-

**The Committee decided that recognition be granted to the institution for D.El.Ed. course for two units (100 students) under clause 7(16) of the NCTE Regulations, 2014 from the academic session 2017-2018."**

3. **AND WHEREAS**, the matter was again placed in 265<sup>th</sup> (part-3) Meeting held on 27<sup>th</sup>, February to 3<sup>rd</sup> March, 2017 of NRC and the Committee decided that.

"...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observation was made:-

- The institution applied for D.El.Ed. course on-line. Date of application is 22.06.2015. At the time of application, land was on rent, later on society/institution purchased land on 19.02.2016, 28.08.2015 and 15.12.2015. As per Regulations, 2014, the land should be on ownership at the time of submission of on-line application. As such, decision taken in 258<sup>th</sup> meeting held from 04<sup>th</sup> to 06<sup>th</sup> October, 2016 be kept in abeyance.

**Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."**

4. **AND WHEREAS**, the Show Cause Notice was issued to the Institution on 01.04.2017, and its reply received on 21.03.2017.

5. **AND WHEREAS**, the matter was placed in 267<sup>th</sup> (Part-3) Meeting held on April 05-07, 2017 of WRC and the Committee decided as under:-

"...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made:-

- Land was neither in the name of the applicant institution nor in the name of the sponsoring society as required under clause 8 (4) (i) of the NCTE Regulations, 2014.

**Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."**

6. **AND WHEREAS**, the Refusal order was issued to the institution on 19.04.2017.

7. **AND WHEREAS**, the institution had filed an appeal to NCTE, Hqrs. On 20.10.2017. The Appellate Authority vide its appeal order dated 01.01.2018 confirms the order.

8. **AND WHEREAS**, the institution had approached the Hon'ble High Court of Delhi At New Delhi, in W.P. (C) No. 11050/2021 dt. 29.09.2021. the operative part is produced here below:-

*"...In view of the aforesaid, the rejection order issued by the NRC dated 19.04.2017, and the Appellate Committee's order dt. 01.01.2018, are liable to be set aside and the recognition granted in favour of the petitioner at the meeting of the NRC held on 04-06.10.2016 is restored.*

*The Western Regional Committee of the NCTE, which now has jurisdiction over institutions in the State of Rajasthan, will issue an order of restoration of recognition in favour of the petitioner within one week.*

*The writ petition is disposed of in these terms."*

9. **NOW THEREFORE**, the institution viz **SARVODAYA GIRLS COLLEGE, PLOT NO. 706, STREET NO. NH-113, VILL-NAYA PADARIYA KALINJARA, TEHSIL/TALUKA-BAGIDORA, POST OFFICE-KALINJARA, DIST-BANSWARA-327606, RAJASTHAN** for **D.El.Ed. course with an annual intake of 100 students taken in 258 meeting of NRC held on October 04-06, 2016 hereby restored.**
10. The institution is required to ensure about the availability of the regular staff for teaching D.El.Ed. course.
11. The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
12. The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
13. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
14. The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.
15. The Norms of staff qualification administrative and professional staff / terms and conditions of service etc shall be as per the provisions of NCTE Regulations 2014.
16. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
17. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display the following as mandatory disclosure: -
- a) Sanctioned programmes along with annual intake in the institution.
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last, quarter.
  - d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e) Fee charged from students.
  - f) Available infrastructural facilities.
  - g) Facilities added during the last quarter.
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information. if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
18. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the within the stipulated time.
19. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
20. The institution shall fill the GIS Application within one month of issue of this order.

21. If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17 of the NCTE Act, 1993.

22. Further, if the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
