ORDER

Whereas in terms of Section 14(1) of the NCTE Act, 1993 **M.J.R.P. COLLEGE OF EDUCATION, N.H.-8, NEW DELHI ROAD, VILL. KANT, POST. ACHROL, TEHSIL AMBER, DIST. JAIPUR-303002, RAJASTHAN** (RJ-2246) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting M.Ed Course of one year duration with an annual intake of 25 (Twenty-five) students on 31.10.2008.

And whereas the original file of the institution, reply of deficiency letter and other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by NRC in its 141st meeting held on May 22-24, 2010. The Committee decided to close the file and return the FDRs, if submitted. Accordingly, NRC issued order dated 01.06.2009 on the following grounds that:-

- **The institution failed to submit complete application as required under clause 7(1) of Regulations 2007, even after receiving deficiency letter, the institution could not remove deficiencies within the stipulated period of 90 days.**

And whereas the institution preferred an appeal dated 30.07.2009 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the said order. The Council after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, came to the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated **01.06.2009** and remand the case to NRC vide order F.No.89-767/2009-Appeal/ dated 08.10.2009 for causing inspection of the institution within a month of issue of this order to ascertain the availability of infrastructure and instructional facilities as per NCTE norms and thereafter pass appropriate order.

And whereas the matter was again placed before the NRC, NCTE in its 152nd meeting held on 23-25 November, 2009 and the committee decided to constitute VT. Accordingly, the inspection was conducted and the VT Report was received on 27.12.2009.

And whereas the original file of the institution, VTR, other related documents, VCD, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by NRC in its 155th meeting held on January 23-24, 2010. The committee decided to issue a show cause notice to the institution. Accordingly, show cause notice issued vide letter No.NRC/NCTE/F-3/RJ-2246/155 Meeting/2010/16210 dated 04.02.2010 on the following points:-

- The land is not in the name of institute.
- Fire safety is not in place.
- The psychology lab. is ill equipped.
- Science lab and language learning lab are ill equipped.

And whereas, the reply submitted by the institution was placed before the NRC, NCTE in its 159th Meeting held on 28th April-1st May, 2010 and the committee decided to issue letter under Clause 7(9) of Regulations 2007. Accordingly, letter of conditional recognition issued on 14.05.2010. In response, the institution submitted reply dated 27.05.2010.

And whereas, the reply submitted by the institution was placed before the NRC, NCTE in its 162nd Meeting held on June 24-27, 2010 and the committee decided to issue a show cause notice to the institution. Accordingly, show cause notice issued vide letter No.NRC/NCTE/RJ-2246/162 Meeting/2010/25916 dated 22.07.2010 on the following points:-

- The appointed faculty has not been selected through duly constituted selection committee as per NCTE norms for M.Ed.

And whereas, the reply submitted by the institution on 12.07.2010 was placed before the NRC, NCTE in its 163rd Meeting held on July 29-31, 2010 and the committee decided to issue letter under Clause 7(11) of Regulations 2007.

Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **M.J.R.P. COLLEGE OF EDUCATION, N.H.-8, NEW DELHI ROAD, VILL. KANT, POST. ACHROL, TEHSIL AMBER, DIST. JAIPUR-303002, RAJASTHAN** (RJ-2246) for conducting M.Ed Course of PG (Level) of one year duration with an annual intake of 25 (Twenty-five) Students under clause 7(11) of NCTE Regulations, 2007 for the academic session 2009-2010.

- (i) **Order for recognition will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.**
- (ii) **The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010.**
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution, failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
