WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 R.L. PATEL P.T.C. COLLEGE, VISHVAMANAGALAM SHARDAGRAM TRUST, PLOT NO. 6 KHASRA NO. 5 VILLAGE, HIMMATNAGAR, DOST. SABARKANTHA-383001, GUJARAT has submitted an application (Code No. APW05463/322368 (ADDL.)) to the Western Regional Committee of NCTE for grant of recognition/permission for permission for Additional intake in existing P.T.C (CO-ED) course with an annual intake of 50 students on 5-01-2007.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the ELE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants permission to R.L. PATEL P.T.C. COLLEGE, VISHVAMANAGALAM SHARDAGRAM TRUST, PLOT NO. 6 KHASRA NO. 5 VILLAGE, HIMMATNAGAR, DOST. SABARKANTHA-383001, GUJARAT, for Additional intake of 50 students in the existing P.T.C (CO-ED) course of ELE of 2 year duration with an annual additional intake of 50(ELE) under clause 7(1) of NCTE (Recognition Norms & Procedure) Regulation 2007. With this the total approved intake for the P.T.C (CO-ED) course to the institution R.L. PATEL PRIMARY TRAINING COLLEGE becomes 100. This permission is subject to fulfillment of the following conditions

- I. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into joint account to be operated along with an officer of the Western Regional Committee.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations 2007.
- IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
