Recognition Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 MAHILA P.T.C COLLEGE, JAMIYAT CHILDRENS VILLAGE, BHUJ HIGHWAY, GANESH BAUG, ANJAR (KUTCH), KUTCH, GUJARAT has submitted an application (Code No.- APW02892/322315) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting P.T.C. (GUJARATI) course with an annual intake of 50 students on 30.12.2005.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee observed that the institution/society was not fulfilling the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the ELE teacher education programme. So committee refused recognition in its 101st Meeting and institution was informed vide letter No.WRC/APW02892/322315/101st/2008/29647-29651 dated 21.02.2008.

3. Institution submitted an appeal to appellate authority against the order No. WRC/APW02892/322315/101st/2008/29647-29651 dated 21.02.2008 and appellate authority reversed the order of Regional Committee vide order No.89-178/2008-Appeal/82504 dated 18.08.2008.

4. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to MAHILA P.T.C COLLEGE, JAMIYAT CHILDRENS VILLAGE, BHUJ HIGHWAY, GANESH BAUG, ANJAR (KUTCH), KUTCH, GUJARAT for conducting P.T.C. (GUJARATI) course of ELE of 2 year duration with an annual intake of 50 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2007.

5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

8. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

9. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.

10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
