CORRIGENDUM

WHEREAS, the recognition was granted to the institution namely: SVC MEMORIAL TEACHER TRAINING COLLEGE, KHASRA NO. 59/136, VILL-DABLI VAS KUTUB, DIST-HANUMANGARH, RAJASTHAN for D.EL.ED Course of two year duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2022-2023 vide order F.NO/WRC/NRCAPP-8686/D.EL.ED./349th meeting/2021 dated 03.03.2022.

AND WHEREAS, vide an E-mail dated:- 22.11.2022 received from Registrar, Shri Khushal Das University, Hanumangarh, Rajasthan enclosing a copy of its previous request letter dated 08.02.2021, 18.11.2022 and copy of letter dated 03.07.2020 issued by State Govt. related to non-requirement of NOC by the University from Dept. of Higher Education, Govt. of Rajasthan regarding running of D.EL.Ed. course and requesting to issue a corrigendum regarding change of affiliating/examining body in continuation of recognition order dated 03.03.2022.

AND WHEREAS, the matter was considered by WRC in its 377th Meeting (Part-2) held on 10th December, 2022 and the Committee decided as under:-

...The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- *Recognition was granted for D.EL.Ed. course vide order dated 03.03.2022 mentioning the affiliating body as Directorate of Elementary Education, Bikaner, Rajasthan.*
- *Email dated 22.11.2022 received from Registrar, Shri Khushal Das University, Hanumangarh, Rajasthan enclosing a copy of its previous request letter dated 08.02.2021, 18.11.2022 and copy of letter dated 03.07.2020 issued by State Govt. related to non-requirement of NOC by the University from Dept. of Higher Education, Govt. of Rajasthan regarding running of D.EL.Ed. course and requesting to issue a corrigendum regarding change of affiliating/examining body in continuation of recognition order dated 03.03.2022.*

In view of the above, the Committee decided that request for change of affiliating/examining body from Directorate of Elementary Education, Bikaner, Rajasthan to Shri Khushal Das University, Hanumangarh, Rajasthan be permitted. Accordingly, a Corrigendum be issued. The concerned State authorities and affiliating body be intimated accordingly. A copy of order regarding related to continuation of recognition be also uploaded on the WRC web portal on NCTE website."

NOW THEREFORE, as per the decision taken by WRC, permission is hereby granted to the institution changing name of Affiliating/Examining Body from **Directorate of Elementary Education, Bikaner, Rajasthan** to **Shri Khushal Das University, Hanumangarh, Rajasthan** from the date of issue of order for conduct of D.EL.Ed. course with immediate effect.


