ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCTE Headquarters conducted inspection of the Rajasthan Shikshak Prashikshan Vidypeeth, Shahura Bagh, Amer Road, Jaipur, Rajasthan on 22.07.2003 and after having received the report/findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under:

- (i) The Principal for B. Ed. Programme is not qualified as per NCTE norms.
- (ii) Out of seven full time regular lecturers appointed for the B. Ed. Section, three do not have NET qualification. It is also not clear as to whether they qualify for exemption from possession of NET.
- (iii) The educational technology lab needs to be strengthened. It does not have adequate number of PCs and electronic publications on education.
- (iv) The number of teaching days for B. Ed. fall short of the requirement laid down in NCTE norms.
- (v) Out of ten lecturers appointed for Shiksha Shastri, eight do not have NET qualification.
- (vi) The list of teachers appointed in the institution has not yet been cleared by the affiliating University.
- (vii) It is not clear from the list of teaching staff provided by the institution as to whether arrangement has been made for part time instructor for teaching Arts and Craft, Music, Physical Education etc.
- (viii) The salary paid to the teaching staff is not in accordance with the pay scales prescribed by UGC / Central Government or State Government.
- (ix) The Endowment Fund has not been put under joint operation with the representative of the NRC.
- (x) The institution does not maintain adequate Reserve Fund.

2. AND WHEREAS, the said report of the inspection team and the reply of the institution were placed before the NRC in its 80th meeting. Having considered the same, the Committee was of the opinion that the reply and supporting documents attached therewith are not satisfactory. Therefore, the Committee decided that a Show Cause Notice be issued to the institution under section 17 (i) of the NCTE Act, 1993. Accordingly, a Show Cause Notice dated 06.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under section 13 of the NCTE Act, 1993, to provide reasonable opportunity of making representation against the proposed action.

3. The reply submitted by the institution was placed before NRC in its 85th meeting, whereby the NRC decided that the institution may submit documentary proof duly certified by the authorized person of the Society (President / Secretary) with regard to each deficiency notified and already communicated through Show Cause Notice dated 06.08.2004 alongwith an Affidavit by President / Secretary of the institution in support of the documents to be submitted.

4. AND WHEREAS, the entire matter was considered by the NRC in its 89th meeting wherein the Committee noted that the reply submitted by the institution is vague and evasive and deficiencies as communicated in Show Cause Notice still exist. Having considered the entire matter, including the deficiencies and their impact on the quality of teacher training/education and after being satisfied that the institution has violated norms and standards laid down under the Rules, Regulations and Orders made or issued under the Act as well conditions subject to which recognition/permission was granted to the institution for the Shiksha Shasri course, decided to withdraw recognition of Rajasthan Shikshak Prashikshan Vidypeeth, Shahura Bagh, Amer Road, Jaipur, Rajasthan for running Shiksha Shasri course with effect from the end of the current academic session 2004-2005.

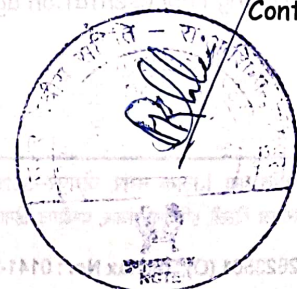
5. AND THEREFORE, the recognition of Rajasthan Shikshak Prashikshan Vidypeeth, Shahura Bagh, Amer Road, Jaipur, Rajasthan for Shiksha Shasri Course stands withdrawn from the end of the current academic session i.e. 2004-2005.

6. As a result of this order, Rajasthan Shikshak Prashikshan Vidypeeth, Shahura Bagh, Amer Road, Jaipur, Rajasthan shall discontinue Shiksha Shasri teacher training course immediately after the academic session 2004-2005 and the concerned University or examining body shall cancel affiliation of the institution in accordance with this order with effect from the end of the current academic session 2004-2005 as provided under sub-section (3) of section 17 of the NCTE Act, 1993..

7. The qualification in teacher education obtained pursuant to that course or training or after undertaking a course or training in the said institution after the academic session 2004-2005, shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government as per sub-section (4) of the Section 17 of NCTE Act, 1993.

8. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.


