WITHDRAWAL ORDER 767, 768, 769

Whereas, the WRC had granted the recognition to Som - Lalit College of Education, Run by Som-Lalit Education & Research Foundation, Behind Hindu Colony, Near Sardar Patel Stadium, Navrangpura, Ahmedabad, Gujarat - 380009 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/98<sup>th</sup>/2007/C-18358 dt. 29.06.2007.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Som - Lalit College of Education, Run by Som-Lalit Education & Research Foundation, Behind Hindu Colony, Near Sardar Patel Stadium, Navrangpura, Ahmedabad, Gujarat - 380009 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 31.12.2015 from the institution, a revised recognition order no. WRC/APW323429/2015/136498 dt. 25.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic unit of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 25.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22<sup>nd</sup> - 24<sup>th</sup>, 2016 and the Committee decided to issue Show Cause Notice dt. 26.08.2016.

And whereas, reply dt. 13.09.2016 was submitted by the institution placed before the WRC in its 290<sup>th</sup> meeting held on March 21<sup>st</sup> - 23<sup>rd</sup>, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 26.08.2016 was issued. The institution replied on 13.09.2016.

A scrutiny of the reply shows that the institution has not submitted the staff profile in the prescribed format nor is it approved by the Registrar, Building Completion Certificate in the prescribed format counter signed by a Govt. Engineer in original, FDRs for Rs.12.00 lakhs (in joint name).

Hence, Recognition is withdrawn from the end of the next academic session."

Now, therefore, the recognition of Som - Lalit College of Education, Run by Som-Lalit Education & Research Foundation, Behind Hindu Colony, Near Sardar Patel Stadium, Navrangpura, Ahmedabad, Gujarat - 380009 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic unit of 50 students), is hereby withdrawn from the academic session 2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.
