

**RESTORATION ORDER**

Whereas, recognition was granted to the institution, namely, 2014 Som - Lalit College of Education, Run by Som - Lalit Education & Research Foundation, Behind Hindu Colony, Near Sardar Patel Stadium, Navrangpura, Ahmedabad, Gujarat - 380009 under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order no. WRC/5-6/98<sup>th</sup>/2007/C-18358-365 dated 29.06.2007.

2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Som - Lalit College of Education, Run by Som - Lalit Education & Research Foundation, Behind Hindu Colony, Near Sardar Patel Stadium, Navrangpura, Ahmedabad, Gujarat - 380009 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 31.12.2014 from the institution, a revised recognition order no. WRC/APW04323/323429/2015/136498 dt. 25.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from session 2015-16.

4. And Whereas, the matter was placed before the WRC in its 255<sup>th</sup> Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 26.08.2016 to the institution.

5. And Whereas, reply dt. 13.09.2016 of institution was placed before the WRC in its 290<sup>th</sup> meeting held on March 21<sup>st</sup> -23<sup>rd</sup>, 2018 and Committee decided as follows:-

*"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 26.08.2016 was issued. The institution replied on 13.09.2016.*

*A scrutiny of the reply shows that the institution has not submitted the staff profile in the prescribed format nor is it approved by the Registrar, Building Completion Certificate in the prescribed format counter signed by a Govt. Engineer in original, FDRs for Rs.12.00 lakhs (in joint name).*

**Hence, Recognition is withdrawn from the end of the next academic session."**

6. And Whereas, a withdrawal order no. WRC/APW04323/323429/Guj./290<sup>th</sup>/2018/196762-769 dt. 04.04.2018 was issued to the institution.

7. And Whereas, the institution had filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 31.12.2018 has decided as follows:-

*"After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to W.R.C. to revisit the matter on receipt of required documentary evidences from the appellant institution.*

*The council hereby remands back the case of Som-Lalit College of Education, Naurangpura, Sardar Patel Stadium Marg, Ahmedabad, Gujarat to the WRC, NCTE, for necessary action as indicated above."*

8. And Whereas, reply dt. 10.01.2019 of institution was placed before the WRC in its 303<sup>rd</sup> meeting held on February 26<sup>th</sup> - 28<sup>th</sup>, 2019 and Committee decided as follows:-

"The original file of the Institution alongwith appeal order dated 16/05/2018 & other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:-

- The institution is required to submit letter granting approval for the appointment of faculty by Affiliating University.
- The institution is required to submit original FDRs towards Endowment Fund and Reserve Fund in Joint name as per Regulations 2014.
- The institution is required to submit building plan approved by the competent authority mentioning name of institution, course, khasra No/ Plot No, total land area, total built up area and earmarked area for each course being run in the same premises.
- The institution is required to submit BCC issued by competent authority.

**Hence, show cause notice be issued under Section 17 of the NCTE Act, 1993 to the institution to submit the from the date of issue of show cause notice failing which the recognition will be withdrawn."**

8. And Whereas, reply dt. 10.01.2019 of institution was placed before the WRC in its 303<sup>rd</sup> meeting held on February 26<sup>th</sup> - 28<sup>th</sup>, 2019 and Committee decided as follows:-

9. And Whereas, show cause notice No. WRC/WRC/APW04323/323429/303<sup>rd</sup>/B.Ed./GUJ./2019/201896-899 dt. 12.03.2019 was issued to the institution.


10. And whereas, reply dt. 10.04.2019 of the institution was placed before the WRC in its 308<sup>th</sup> meeting held on June 19<sup>th</sup>-21<sup>st</sup>, 2019 and the Committee decided as follows :-

"The Show Cause Notice was issued to the institution on 12/03/2019.

The institution has submitted reply of Show Cause Notice on 10/04/2019.

On perusal of the reply of the institution the committee observed that the reply of the institution is as per NCTE Regulations 2014 & amendment Regulations 2017.

**Hence, the committee decided to restore the recognition of two units of B.Ed. programme (total 100 students)."**

11. Now Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 308<sup>th</sup> meeting and revised recognition order no. /APW04323/323429/2015/136498 dt. 25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) will remain continue.

12. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
