AND WHEREAS, the visiting team constituted by the WRC Inspected the new premises on 06.12.2015.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 240th Meeting held on January 20-22, 2016. The Committee decided as under:-

"...This is a case of shifting. The VT Inspected the building on 06/12/2015 and has recommended the case. The CD shows good academic and physical Infrastructure. Hence, shifting is permitted. The attention of the applicant be drawn to the Clause 2 (b), 3 (a) and 8 of the NCTE Regulations, 2014, regarding the necessity of all institutions to be composite."
