ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Shri Puran Prasad Gupta Memorial Degree College, C-23, Side -A, UPSIDC Sikandra, Agra - 282007, U.P. had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting B.Ed. course of one year duration from the academic session 2002-2003 with an annual intake of 100 (One Hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has made arrangements for conducting in rented premises at C-23, Side -A, UPSIDC Sikandra, Agra - 282007, U.P.
- (iii) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 3,00,000.00 (Rupees Three lacs Only).
- (iv) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Shri Puran Prasad Gupta Memorial Degree College, C-23, Side -A, UPSIDC Sikandra, Agra - 282007, U.P. for B.Ed. one year course from the academic session 2002-2003 with an annual intake of 100 (One Hundred) students Subject to fulfillment of the following :-

- (a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report to this effect, duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (b) The institution shall shift to its own premises within THREE YEARS from the date of recognition.
- (c) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
- (d) That the **Reserve Fund** for an amount equal to three months salary of the staff be maintained, in the form of FDR in favour of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only.
- (e) The institution shall comply with the various all other norms and standards as prescribed in the NCTE Regulations.

4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University. **✓ 82**

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

6. The institution shall submit to the Regional Committee a **Self-Appraisal Report** at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
