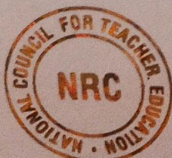

9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

11. It was observed by the Regional Committee that the land is not in the name of the institution as required under clause 8(7) of Regulation 2007. Hence, it is required that the land is to be registered in the name of the institution on ownership basis i.e. bainama, sale deed gift deed within one months failing to which recognition stands cancelled automatically.
