ORDER

AND WHEREAS, (a) the institution namely **FS College of Education**, Plot/ Khasra No. 130,131,199, Village - Arnoj, Post office - Shikohabad, Tehsil/Taluka - Shikohabd, Town/City - Shikohabd, District - Firozabad, State - Uttar Pradesh - 283203 was granted recognition for D.El.Ed course of two years duration with an annual intake of 50 students from the academic session 2012-2013 vide order No. F.NRC/NCTE/NRCAPP-1668/202nd Meeting/2012/27700-707 dated 31.07.2012 and D.El.Ed. (Addl.) intake of two years duration with annual intake 100 (2 Units) from the academic session 2016-2017 vide order No. File No. NRC/NCTE/Recognition/ D.El.Ed./2016 /43468-3892 dated 03.03.2016.

AND WHEREAS, (b) the institution namely **S R D College of Education**, Plot no. 593, 594, Street -NA Village -Ussaini, P.O. Tundla, Tehsil -Tundla, Town -Firozabad, District -Firozabad- 283203, Uttar Pradesh was granted recognition for D.El.Ed course of two years duration with an annual intake of 100 (2 Units) students from the academic session 2016-2017 vide NRC order No. F.NRC/NCTE/NRCAPP-11118-D.El.Ed.Recognition/2016/146821-7691 dated 02.05.2016.

AND WHEREAS, (c) the institution namely **S R D Institute**, Plot no. 130/2, Street - 0, Village - Aronj, P.O. -Shikohabad, Tehsil - Shikohabad, Town - Shikohabad, District -Firozabad - 205135, Uttar Pradesh was granted recognition for D.El.Ed course of two years duration with an annual intake of 50 (01 Unit) students from the academic session 2018-2019 vide order No. F.NRC/NCTE/NRCAPP-11092/2018/280th/Meeting/2018/ 189020-25 dated 12.02.2018.

AND WHEREAS, (d) the institution namely **MR COLEGE** , Plot No - 130/2, Village -Arnoj, Post Office - Shikohabad, Tehsil - Shikohabad, Town/City - Shikohabad, District - Firozabad - 205135, Uttar Pradesh was granted recognition for D.El.Ed course of two years duration with an annual intake of 50 (one Unit) students from the academic session 2012-2013 vide NRC order No. F.NRC/NCTE/NRCAPP-1663/202nd Meeting/2012/27985-992 dated 03.08.2012 and D.El.Ed (Addl.) intake of two years duration with an annual intake of 100 (two Units) students from the academic session 2016-2017 vide order No. F.NRC/NCTE/Recognition/ D.El.Ed. /2016/146821-7694 dated 02.05.2016 and vide **Corrigendum** order no. F.NRC/NCTE/NRCAPP-2016/146821-7694 dated 02.05.2016 and vide **Corrigendum** order no. F.NRC/NCTE/NRCAPP-11073/253rd Meeting (Part-II) 2016/154311-15 dated 22.07.2016 reduce the intake two units to one unit for D.El.Ed. Course.

2. **WHEREAS**, Fulan Singh Jan Kalyan Trust, Street - Sita Nagar, Village - Nagla Bhau, P.O. Firozabad, Tehsil - Firozabad, Town - Firozabad, District - Firozabad - 283203, Uttar Pradesh has submitted a letter dated 13-08-2021 enclosing therewith a copy of the Notification issued by Govt. of Uttar Pradesh notifying F S University (a Private University), NH-19, Near Balaji Mandir, Shikohabad, Distt Firozabad (UP) for permission to issue necessary orders for admission, instructions, examination and award of degree in the name and style of F S University (a Private University), NH-19, Near Balaji Mandir, Shikohabad Distt. Firozabad (UP).

3. **AND WHEREAS**, the NRC in its 365th meeting (Volume -2) held on 8th & 9th March 2022 change the affiliating University from B.R. Ambedkar University, Agra to F.S. University, Shikohabad for B.Ed., B.Ed. additional intake and M.Ed. course in the light of Notification of Uttar Pradesh Govt. Letter No. 747/Sattar-1-2021-20 (19)/2020 dated 9/6/2021 wherein F. S University have been granted status of University under the Uttar Pradesh Private University Act, 2019 (UP Act No. 12 of 2019).

4. **AND WHEREAS**, the request of change of affiliation body for D.El.Ed. programmes from SCERT to F. S University in respect of four of its colleges (FS College of Education, SRD College of Education, SRD institute, MR College) was rejected by NRC in its 365th meeting.

5. **AND WHEREAS**, the foresaid decision was challenged by the applicant institution before High Court of Delhi in W.P (C) No. 13122/2022 whereby the petitioner also claimed parity with the decisions of NRC wherein NRC, NCTE allowed the change in affiliating body in similar circumstance.

6. **AND WHEREAS**, accordingly, the Hon'ble Court vide order dated 13/9/2022 directed NRC to take afresh decision on petitioner application, taking into consideration the decision noted in the order dated 9/9/2022 and also response, if any, that is received from SCERT, Govt. of Uttar Pradesh, within a period of four weeks from date of order.

7. **AND WHEREAS**, the response from SCERT Uttar Pradesh regarding affiliation from D.El.Ed. was received on 24/9/2022 is as under: उपर्युक्त के दृष्टिगत अनुरोध है कि डीएलएडो प्रशिक्षण संचालन की सम्बद्धता के सम्बन्ध में निजी विश्वविद्यालय को सम्बन्धन निकाय अधिकृत किये जाने अथवा न किये जाने के सर्वर्भ में अभिमत दिये जाने हेतु राज्य शैक्षिक अनुसंधान एवं प्रशिक्षण परिषद्, उ०प्र०, लखनऊ अधिकृत निकाय नहीं है। प्रश्नगत प्रकरण के सम्बन्ध में उच्च शिक्षा विभाग से अभिमत लिया जाना समीचीन होगा।


8. **AND WHEREAS**, the institution filed a Cont. case 1139/2022 in the High Court of Delhi against the order dated 13/09/2022 passed in W.P. (C) No. 13122/2022. The matter was considered by NRC in its 383th Meeting held on 31th October & 1st November, 2022 and in the light of above circumstances the Committee decided **to change affiliating body namely SCERT, Lucknow to FS University, Shikohabad on the following grounds:**

- a. The powers of University vested under section 11 (d) of the Uttar Pradesh Private University Act 2019 are as under "to grant, subject to such condition as the University may determine, diplomas or certificates to, and confer degree or other academic distinction on the basis of examination, and to withdraw any such diplomas, certificate, degree or other academic distinctions for good and sufficient cause".
- b. The NRC has already taken similar decisions of change in affiliating body from SCERT to University in several other cases after receiving Legal opinions.
- c. Further, the institution and affiliating university both shall submit undertaking on non-judicial stamp paper to the effect that the institution shall exclusively be affiliated to FS University only and the F.S University owns that it will affiliate the aforesaid colleges as Department of Education under the F. S University.
- d. A letter to the Department of Higher Education, Govt. of Uttar Pradesh will be sent in conformity with the letter received from SCERT, Uttar Pradesh..

NOW THEREFORE, the colleges i.e. F. S College of Education, SRD College of Education, SRD institute and M.R. College merged in Department of Education F.S. University, Near Balaji Mandir, Shikohabad, District - Firozabad - 283203, Uttar Pradesh with the Change of affiliating body namely SCERT to F.S. University, Near Balaji Mandir, Shikohabad, District - Firozabad - 283203, Uttar Pradesh for admission, conduct of classes, examination and awarded of degree of D.El.Ed. course.

The other contents of the recognition order of the aforesaid colleges for D.El.Ed. Course issued time to time with approved intake will remain unchanged.
