ORDER

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 College of Innovative Management & Science, HERS Educational Campus, Vipul Khand- 6, Gomti Nagar, Lucknow-226010, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration with an annual intake of 100 (One hundred Only) students on 26.08.2008.

AND WHEREAS, the inspection of the said institution under section 14 was conducted by visiting team on 05.07.2009.

AND WHEREAS, the original file of the institution, VTR under section 14 along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 144<sup>th</sup> Meeting held from July 12-14, 2009 and the committee decided to issue show cause notice. Accordingly, Show-cause notice issued to the institution on 22.07.2009 on the following grounds:-

- The infrastructure used for running AICTE approved courses are proposed to be used for running proposed B.Ed. course. This fact is being sent to AICTE for information and necessary action.
- The land is not in the name of the Institution.
- All laboratories are ill equipped.
- Computer facility is common for PGDM and proposed B.Ed. course students.
- The course-wise demarcated built up area in the building map is not shown.
- The play grounds are not developed.
- The number of titles in the library is not as per NCTE norms.
- Language learning facilities are not available.

AND WHEREAS, the original file of the institution, reply of the Institution under section 14 along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 147<sup>th</sup> Meeting held on August 16-17, 2009 and the committee decided to refuse recognition for B.Ed. course. Accordingly, refusal order issued to the institution on 31.08.2009 on the following grounds:-

- The deficiencies regarding Land and Labs still exist.

AND WHEREAS, the above said institution, thereafter preferred an appeal dated 10.09.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order. After perusal of documents, memorandum of appeal, affidavit, VT Report and considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order and remand the case to NRC for further processing for issue of Letter of intent prior to recognition. Accordingly, Letter of intent prior to recognition issued to the institution on 16.12.2009.

AND WHEREAS, the original file of the institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 155<sup>th</sup> meeting held from January 23-25, 2010 and the committee decided to refuse recognition to B.Ed. course and return FDRs, if submitted. Accordingly, refusal order issued to the institution on 04.02.2010.

AND WHEREAS, the above said institution, again preferred an appeal dated 01.02.2010 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order. After perusal of documents, memorandum of appeal, affidavit, VT Report and considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order and remand the case to NRC for re-examination of the reply dated 06.01.2010 submitted by the institution, and for issuing a speaking order.

AND WHEREAS, the matter was placed before the NRC in its 159<sup>th</sup> meeting held from April 28-May-01, 2010 and the committee decided to issue a letter to the institution directing to appoint faculty as per NCTE norms for B.Ed. Accordingly, letter issued to the institution communicating the deficiencies on 14.05.2010

AND WHEREAS, reply received was placed in the 162<sup>nd</sup> Meeting held from June 24-27, 2010 and it was decided to issue show-cause notice to the institution on the following points:-

- The experience certificate of Dr. Rajesh Kumar Singh, Principal has not been counter signed by affiliating University.
- There is no Faculty to teach Methods of Teaching Physics, and Mathematics.
- The Institution has not submitted the appointed Faculty list approved by affiliating University.

AND WHEREAS, the reply received from the institution has been considered by NRC in its 176<sup>th</sup> Meeting held from January 7-11, 2010. The reply has been found satisfactory. Hence, NRC decided that formal recognition to the institution for B.Ed. course under clause 7(11) of NCTE Regulation 2009 and in terms of Section 14(3)(a) of NCTE Act, 1993 with an annual intake of 100 students be given to the institution subject to the usual conditions.

AND WHEREAS, the NCTE has issued letter No.48-6/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on 26<sup>th</sup> July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session 2011-2012 and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its 166<sup>th</sup> Meeting held on 9<sup>th</sup> September, 2010 and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations be issued from the session 2010-2011 subject to the following condition:-

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **College of Innovative Management & Science, HERS Educational Campus, Vipul Khand- 6, Gomti Nagar, Lucknow-226010, Uttar Pradesh** for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:-

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

- The Institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.


If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.


