ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **Hazari Lal Degree College, Vill-Pahadapur, Post- Khalgaon, Tehsil- Mahmoodabad, District- Sitapur- 261301, U.P.** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting **B.Ed** Course of **One year** duration with an annual intake of **100 (One Hundred Only)** students on **11.01.2008**.

2. AND WHEREAS on the basis of scrutiny of the documents submitted by the institution the documents attached therewith, input received from the Visiting Team Report and videography along with related documents, the matter was placed before the NRC in its 138<sup>th</sup> Meeting held on 14<sup>th</sup> to 16<sup>th</sup> March, 2009, the committee decided to issue Show Cause Notice for refusing the recognition to the institution. Accordingly SCN letter was issued to the institution vide letter no. F.NRC/NCTE/F-3/UP-2857/138 Meeting/2009/72088 dated 23.03.2009.

3. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur on 20.04.2009. The matter was placed before the Committee in its 140<sup>th</sup> NRC Meeting held on 25<sup>th</sup> to 26<sup>th</sup> April, 2009 and the Committee decided to refuse the recognition and return the FDRs if submitted. Accordingly refusal order was issued to the institution vide letter no. F.NRC/NCTE/F-7/UP-2857/F-7/UP-2857/2009/10904-10910 dated 30.09.2009.

4. AND WHEREAS the above said institution, thereafter preferred an appeal dated 13.07.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.

5. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the presentation, the Council reached the conclusion that the appeal should be accepted and the case should be remanded back to NRC for further processing the case for issuance of Letter of Intent prior to Recognition under Clause 7(9) of NCTE Regulations 2007 vide its order no. **F.NO. 89-668/2009 -APPEAL dated 05.01.2010.** Accordingly Letter of Intent prior to Recognition was issued to the institution on 18.02.2010. The applicant institution had submitted the representation to the NRC NCTE on 11.03.2010. The matter was considered by the Committee in its 157 meeting and decided to issue Show Cause Notice to the institution accordingly show cause notice was issued to the institution on 31.03.2010. the applicant institution had submitted the representation to the NRC NCTE on 12.04.2010. The matter was placed before the Committee in its 158<sup>th</sup> Meeting and decided to issued letter under clause 7(11) of regulations 2007.

6. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Hazari Lal Degree College, Vill- Pahadapur, Post- Khalgaon, Tehsil- Mahmoodabad, District- Sitapur- 261301, U.P.** for conducting **B.Ed** Course of **Secondary (Level)** of **one year** duration with an annual intake of **100 (One Hundred only)** Students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009 and 06.10.2009.

- I. **The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.**
- II. **Formal order for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.**

4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

11. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.



**ORDER**

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **Hazari Lal Degree College, Vill-Pahadapur, Post- Khalgaon, Tehsil- Mahmoodabad, District- Sitapur- 261301, U.P.** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting **B.Ed** Course of **One year** duration with an annual intake of **100 (One Hundred Only)** students on **11.01.2008**.

2. AND WHEREAS on the basis of scrutiny of the documents submitted by the institution the documents attached therewith, input received from the Visiting Team Report and videography along with related documents, the matter was placed before the NRC in its 138<sup>th</sup> Meeting held on 14<sup>th</sup> to 16<sup>th</sup> March, 2009, the committee decided to issue Show Cause Notice for refusing the recognition to the institution. Accordingly SCN letter was issued to the institution vide letter no. F.NRC/NCTE/F-3/UP-2857/138 Meeting/2009/72088 dated 23.03.2009.

3. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur on 20.04.2009. The matter was placed before the Committee in its 140<sup>th</sup> NRC Meeting held on 25<sup>th</sup> to 26<sup>th</sup> April, 2009 and the Committee decided to refuse the recognition and return the FDRs if submitted. Accordingly refusal order was issued to the institution vide letter no. F.NRC/NCTE/F-7/UP-2857/F-7/UP-2857/2009/10904-10910 dated 30.09.2009.

4. AND WHEREAS the above said institution, thereafter preferred an appeal dated 13.07.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.

5. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the presentation, the Council reached the conclusion that the appeal should be accepted and the case should be remanded back to NRC for further processing the case for issuance of Letter of Intent prior to Recognition under Clause 7(9) of NCTE Regulations 2007 vide its order no. **F.NO. 89-668/2009 -APPEAL dated 05.01.2010**. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Hazari Lal Degree College, Vill- Pahadapur, Post- Khalgaon, Tehsil- Mahmoodabad, District- Sitapur- 261301, U.P.** for conducting **B.Ed** Course of **Secondary (Level)** of **one year** duration with an annual intake of **100 (One Hundred only)** Students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009 and 06.10.2009.

**I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.**

**II. Formal order for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.**

4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.




