ORDER

- (b) The institution has constructed the building for conducting the course on the above-mentioned land.
- (c) The institution has created an Endowment Fund of Rs. 5,00,000/- (Rupees Five lacs Only) and a Reserve Fund of Rs. 3,00,000/- (Rupees Three lacs Only).
- (d) The institution has initiated the process for recruitment of Principal Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Shambhu Dayal (P.G.) College, G.T. Road, Ghaziabad, U.P. for an intake of 100 (One Hundred) seats in B.Ed. course of one year duration with effect from the academic session 2003-2004 subject to fulfillment of the following before the commencement of the session.
