ORDER

Shambhu Dayal (P.G.) College, G.T. Road, Ghaziabad, U.P. had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of One Year duration from the academic session 2003-2004 with an annual intake of 100 (One Hundred) students in terms of section 14(1) of NCTE Act, 1993.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the inputs received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above-mentioned land.
- The institution has created an Endowment Fund of Rs. 5,00,000/- (Rupees Five lacs Only) and a Reserve Fund of Rs. 3,00,000/- (Rupees Three lacs Only).
