ORDER

Change of name of the institution, Affiliating Body & Examining Authority

WHEREAS, the recognition was granted to the institution namely **Phonics School of Education, Plot/ Khasra No. 537/1/3/4m, Village-Imli Khera, Post Office/ Tehsil/Taluka/Town/City-Roorkee, District-Haridwar-247667, Uttarakhand** for conducting **B.Ed.** course of one-year duration with an annual intake 100 students vide order No. NRC/NCTE/NRCAPP_191/220th meeting/2013/64805-811 dated 14.11.2013 followed by revised recognition order No. F. No. F.No./NRC/NCTE/NRCAPP-191/2015/103784-88 dated 25.05.2015.

2. AND WHEREAS, the institution has submitted a representation vide letter dated 19.11.2025 received in NRC office dated 12.12.2025 requesting to change the Name of the institution from “**Phonics School of Education**” to “**Department of Education, Phonics University**”, Affiliating Body & Examining from “**Sri Dev Suman Uttarakhand University (SDSUV)**” to “**Phonics University**” for offering **B.Ed.** course from the Academic Year 2025-26.

3. AND WHEREAS, the matter was placed before NRC in its 454th (Vol-I) Meeting held on 29th & 30th December 2025, and the Committee decided as under: -

“The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:

- The recognition was granted by NRC to the institution namely **Phonics School of Education, Plot/ Khasra No. 537/1/3/4m, Village-Imli Khera, Post Office/ Tehsil/Taluka/Town/City-Roorkee, District-Haridwar-247667, Uttarakhand** for offering **B.Ed.** Course vide Order No. NRC/NCTE/NRCAPP-191/220th meeting/2013/64805-811 dated 14.11.2013 with an annual intake of 100 from the academic session 2014-2015 followed by revised recognition order of two-year duration with an annual intake of 100 seats i.e. two basic units of 50 students each from the academic session 2015-2016 vide Order No. NRC/NCTE/NRCAPP-191/2015/103784-88 dated 25.05.2015.
- The above institution running under the **Seth Bimal Prasad Jain Educational Trust** has now established a **Private University** namely **Phonics University** vide Gazette Notification No. 245/xxxv (3)/2025/16(1)/2025 dated 03/07/2025 under provisions of the **Uttarakhand Private Universities (Amendment) Act, 2025 (Act No. 13 of 2025)**.
- The university vide letter dated 19/09/2025 has requested the NRC to change the name of the institution from “**Phonics School of Education**” to “**Department of Education**” & Affiliating Body to “**Phonics University Roorkee**” & Examining Authority from “**Sri Dev Suman Uttarakhand University**” to “**Phonics University**” for offering its **B.Ed.** course from the academic session 2025-26.

In view of the above, the Committee considered the matter and permitted as under: -

- The name of the institution be changed from "**Phonics School of Education**" to "**Department of Education**" for offering B.Ed. Course with an annual intake of 100 students i.e. two basic units of 50 students each at Plot/ Khasra No. 537/1/3/4m, Village-Imli Khera, Post Office/ Tehsil/Taluka/Town/City-Roorkee, District-Haridwar-247667, Uttarakhand.
- The affiliating body be changed from "**Sri Dev Suman Uttarakhand University**" to "**Phonics University, Roorkee**" for offering B.Ed. Course with an annual intake of 100 students i.e. two basic units of 50 students each.
- The Examining Authority be changed from "**Sri Dev Suman Uttarakhand University**" to "**Phonics University, Roorkee**" for offering B.Ed. Course with an annual intake of 100 students i.e., two basic units of 50 students each.

Order be issued accordingly"

4. **NOW THEREFORE**, in terms of above decision of NRC, the institution is hereby permitted to change its name from "**Phonics School of Education**" to "**Department of Education, Phonics University**" and change of Affiliating Body and Examining Authority from "**Sri Dev Suman Uttarakhand University**" to "**Phonics University, Roorkee** for conducting B.Ed. course of two-year duration of 100 students.
