ORDER

24 JUN 2010

WHEREAS **Vaishno Devi B.Ed Training College, Gondahi Chergarh Kunda, Pratapgarh, Uttar Pradesh** of recognition for B.Ed Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 27.12.2004.

2. AND WHEREAS the competent authority had constituted a visiting team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 113th Meeting held on 18th to 19th January, 2007, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided that recognition be granted to B.Ed Course of one year duration with an annual intake of 100 (One Hundred Only) subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/ State Govt./ Affiliating University given effect before the commencement of the course. Accordingly letter was issued vide letter no. F.NRC/NCTE/F-7/13571-14000 dated 24.01.2007.

4. AND WHEREAS the applicant institution had not submitted representation to the NRC NCTE, Jaipur. The Matter was considered by the Committee in its 141st meeting held on 22nd to 24th May, 2009 and the committee decides to refuse the recognition and return the FDR's if submitted. Accordingly order of refusal was issued to the institution on 25.01.2010. The above said institution, thereafter preferred an appeal dated 26.02.2010 to the NCTE, New Delhi under section 18 of the NCTE Act 1993 against the aforesaid order.

5. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the presentation, the Council reached the conclusion that there was no ground to accept the appeal, and that should be rejected. Accordingly, the appeal was rejected and NRC's order dated 25.01.2010 was confirmed with the modification that the refusal of recognition may be changed to withdrawal of recognition effective from the ensuing academic session.

6. AND WHEREAS the Matter was placed before the committee in its 159th Meeting held on 28th April to 01st May, 2010 and the committee decides:

7. NOW THEREFORE recognition to **Vaishno Devi B.Ed Training College, Gondahi Chergarh Kunda, Pratapgarh, Uttar Pradesh** for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby Withdrawn effective from the ensuing academic session.
