**CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely **Mohan Memorial Prayag Mahavidyalaya, Village-Shivdashichak, Post office-Basuchak, Tehsil-Saidpur, District-Ghazipur, Uttar Pradesh** for offering B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2009-2010 vide order No. F.NRC/NCTE/F-7/UP-3254/145<sup>th</sup> meeting/2009/7817-7824 dated 12.08.2009 followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order dated 10.03.2016.

2. **AND WHEREAS**, as per decision of NRC in its 401<sup>st</sup> meeting, the institution was permitted to change the premises from Village- Shivdashichak, Post office- Basuchak, Tehsil-Saidpur, **District- Ghazipur- 233306, Uttar Pradesh** to Plot No. 1211K, 1213, 1214 1215, 1216 & 1217, village- Majhauri, Post- Jharokalan Tehsil- Duddhi, **District- Sonbhadra, Uttar Pradesh**. Accordingly, an Order was on **11.07.2023**.

3. **AND WHEREAS**, the matter was placed before NRC in its 433<sup>rd</sup> meeting held on 30<sup>th</sup> to 31<sup>st</sup> January, 2025 and the Committee decided that the institution be issued Show Cause Notice on the following grounds: -

- *The institution has not submitted proof/ evidence to prove that it is a multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.*
- *The institution has not submitted the latest Certified registered land documents issued by the Registering Authority.*
- *The institution has not submitted the Blueprint of approved Building Plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as classrooms etc. along with approval letter issued by Competent Government Authority.*
- *The institution has not submitted a Land Use Certificate issued by the Competent Government Authority to use the land for educational purposes.*

- *The institution has not submitted the latest Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.*
- *The institution has not submitted the certified copy of a site plan with demarcated land area for running different courses.*
- *The institution has not submitted the Building Safety Certificate issued by the Competent Government Authority.*
- *The institution has not submitted the Fire Safety Certificate issued by the Competent Government Authority.*
- *The institution has not submitted a Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.*
- *The institution has not submitted a Building Completion Certificate signed by the Competent Government Authority.*
- *The institution has not submitted the latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative along with notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/ appointed faculty in the prescribed proforma.*
- *The institution has not submitted details of salary disbursed to the faculty along with one year Bank statement and account number of each faculty member.*
- *The institution is required to submit original valid Fixed Deposit Receipts from the Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint name of RD, NRC, NCTE & the representative of Management along with duly filled up Form "A" in original, verified/ signed by the Manager of the Bank.*
- *The institution has not submitted downloaded copies of documents from the website of the institution as per provisions of 7(14) of the NCTE Regulations, 2014.*
- *The website of the institution is not updated as required under clause 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.*
- *The institution is required to submit the copies of the affiliation orders for the last three years issued by the affiliating body concerned for each course being run by the institution / society.*

***Hence, the Committee decided that First Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 21 days from the date of issue of Show Cause Notice."***

Accordingly, show cause notice was issued to the institution on 26.03.2025. The institution has not submitted any reply of show cause notice.



4. **AND WHEREAS**, the matter was placed before NRC in its 447<sup>th</sup> Meeting held on 03<sup>rd</sup> & 04<sup>th</sup> September 2025 and the Committee decided as under:-

*“The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -*

- ❖ *As per decision of NRC in its 433<sup>rd</sup> Meeting held on 30<sup>th</sup> and 31<sup>st</sup> January 2025, First SCN was issued to the institution on 26.3.2025.*
- *The institution has not submitted the reply of First Show Cause Notice dated 26.3.2025.*

**Hence, the Committee decided that Final Show Cause Notice be issued to the institution to submit reply within 7 days from the date of issue of Final Show Cause Notice.**

5. **AND WHEREAS**, final show cause notice was issued to the institution on 03.11.2025. The institution has submitted reply of final show cause notice on 26.11.2025.

6. **AND WHEREAS**, the reply of the institution was placed before NRC in its 453<sup>rd</sup> meeting held on 11<sup>th</sup> & 12<sup>th</sup> December, 2025 and the Committee decided as under:-

*“The file of the institution along with other related documents NCTE Act 1993 NCTE Rules 1997, NCTE Regulations 2014, Standards operating procedure (SOP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:-*

1. *The recognition was granted to the aforesaid institution for offering B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2009-2010 vide order No. F.NRC/NCTE/F-7/UP-3254/145<sup>th</sup> meeting/2009/7817-7824 dated 12.08.2009 followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order dated 10.03.2016.*
2. *As per the decision of NRC taken in its 447<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> March 2025, final show cause notice was issued to the institution on 03.11.2025 for compliance of the conditions mentioned in the revised recognition order.*
3. *The institution has submitted a reply to show cause notice on 26.11.2025. the Committee considered the said reply and found the same satisfactory.*



*In view of the above, the Committee decided that the recognition granted to the institution vide order dated 12.08.2009 followed by the revised recognition order dated 10.03.2016 for offering B.Ed. course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each be continued.*

*Continuation order be issued accordingly."*

7. **NOW THEREFORE**, in view of the decision taken by NRC, the recognition granted to the institution namely **Mohan Memorial Prayag Mahavidyalaya, Plot No. 1211K, 1213, 1214 1215, 1216 & 1217, village- Majhauri, Post- Jharokalan Tehsil- Duddhi, District- Sonbhadra, Uttar Pradesh** for offering B.Ed. course of two year duration with an annual intake of 100 students is hereby continued.
