ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Dr. Bhim Rao Ambedkar Mahavidyalaya, VPO- Kaithola, Tehsil- Colonel Ganj, District- Gonda-271001, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of One year duration with an annual intake of 100 (Hundred only) students on 29.07.2008.

AND WHEREAS, the Inspection of said Institution was conducted on 05.09.2009.

AND WHEREAS, on scrutiny perusal of the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from, recommendation of the State Government, the Northern Regional Committee in its 150 Meeting held from 09th to 11th October, 2009 decided to issue Show Cause Notice on certain deficiencies. Accordingly show cause notice was issued to the institution on 29.10.2009.

AND WHEREAS, the matter was placed before NRC in its 154th Meeting held from 09th to 11th January, 2010 & as per the decision of NRC, recognition was refused vide order dated 18/01/2010.

AND WHEREAS, the above said Institution, thereafter preferred an appeal before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remanded back to NRC by the Council vide order dated 05.03.2010. for issue letter of intent prior to grant of recognition under clause 7(9) of the NCTE Regulation, within 15 days of issue of this order. Accordingly letter of intent was issued on the institution on 27.03.2010.

AND WHEREAS, the matter was placed before NRC in its 159th Meeting held from 28th April to 01st May, 2010 & as per the decision of NRC, show cause notice was issued to the institution on 11.05.2010 & reply of the same was received on 10.06.2010.

AND WHEREAS, the matter was placed before NRC in its 162nd Meeting held from 24th to 27th June, 2010 & as per the decision of NRC, show cause notice was issued to the institution on 17.07.2010.

AND WHEREAS, the reply of the institution received in the office of NRC on 16/07/2010 was carefully considered by NRC in its 163rd Meeting held from 29th to 31st July, 2010 and committee decided that the recognition for B.Ed. Course under clause 7(11) of NCTE Regulation, 2009 be granted to the Institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Dr. Bhim Rao Ambedkar Mahavidyalaya, VPO- Kaithola, Tehsil- Colonel Ganj, District- Gonda-271001, Uttar Pradesh for conducting B.Ed. One year Course with an annual intake of 100 (Hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions as per decision taken by NRC in its 166th meeting.

- i) The admission of the students shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011 failing which admission for additional seats shall be given from the academic session 2011-2012.
- ii) Formal recognition / permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the academic session 2011-2012.
- i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

A copy of the format is enclosed with the order. 731

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
