ORDER: CHANGE IN THE NAME OF INSTITUTION

WHEREAS, recognition was granted to the institution namely **Meera Memorial Mahila Mahavidyalay Shikshan Evam Prashikshan Sansthan, Village-Pandeypur, Post office- Takha, Tehsil-Rasra, Distt. Ballia-221709, Uttar Pradesh** for conducting B.Ed. course of two year duration with an annual intake of 100 students from the academic session 2015-2016 vide order No. F.NRC/NCTE/NRCAPP-4315/233rd Meeting (Part-VI)/90346-435 dated **03.03.2015**.

2. **AND WHEREAS**, the institution vide letter dated 07.04.2026 has requested the Northern Regional Committee to change the name of the institution from **Meera Memorial Mahila Mahavidyalay Shikshan Evam Prashikshan Sansthan** to **Meera Memorial Mahavidyalay Shikshan Evam Prashikshan Sansthan** and change the status of the institution from Girls to Co-Ed.

3. **AND WHEREAS**, the matter was placed before NRC in its 462nd Meeting held on 16th & 17th April, 2026. The Committee considered the representation of the institution and decided as under:-

“The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:

- ❖ *Recognition was granted to the aforesaid institution for offering B.Ed. course of two-year duration with annual intake of 100 students from the academic session 2015-2016 vide Order No. NRC/NCTE/NRCAPP-4315/233rd meeting (Part-VI)/90346-435 dated 03.03.2015.*
- ❖ *The institution vide letter dated 07.04.2026 has requested the Northern Regional Committee to change the name of the institution from **Meera Memorial Mahila Mahavidyalay Shikshan Evam Prashikshan Sansthan** to **Meera Memorial Mahavidyalay Shikshan Evam Prashikshan Sansthan** and change the status of the institution from Girls to Co-Ed.*

4. **NOW THEREFORE**, in terms of above decision of NRC, the institution namely Meera Memorial Mahila Mahavidyalay Shikshan Evam Prashikshan Sansthan, Village-Pandeypur, Post office- Takha, Tehsil-Rasra, Distt. Ballia-221709, Uttar Pradesh is hereby permitted to change its name from “**Meera Memorial Mahila Mahavidyalay Shikshan Evam Prashikshan Sansthan**” to “**Meera Memorial Mahavidyalay Shikshan Evam Prashikshan Sansthan**” offering the B.Ed. Course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each **at Village-Pandeypur, Post office- Takha, Tehsil-Rasra, Distt. Ballia-221709, Uttar Pradesh** and change the status of the institution from **Girls to Co-Ed.** with immediate effect.
