Change of name of the institution

WHEREAS, recognition was granted to the institution namely Khalsa College of Education, Plot/ Khasra No. 291-294, 302-307, P.O. Ranjit Avenue Amritsar, District-Amritsar-143002, Punjab for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006 vide Order No. NRC/NCTE/F-3/PB-258/9324-9333 dated 19.08.2005 followed by an additional intake in B.Ed. course with an annual intake of 100 students vide Order No. NRC/NCTE/NRCAPP-2822/3978/2851/233rd Meeting/90753-760 dated 03.03.2015. Revised recognition Order was issued to the institution for offering B.Ed. course of two-year duration with an annual intake of 200 students from the academic session 2015-2016 vide Order No. NRC/NCTE/PB-258+NRCAPP-2822/2015/106963-67 dated 29.05.2015.

AND WHEREAS, recognition was also granted to the institution for conducting M.Ed. course of one-year duration with an annual intake of 25 students vide Order No. NRC/NCTE/PB-581/59500-506 dated 27.08.2008 followed by revised recognition Order with an annual intake of 50 students from the academic session 2015-2016 vide Order No. NRC/NCTE/PB-581/2015/108129 dated 30.05.2015.

- ❖ Recognition was granted to the aforesaid institution for offering B.Ed. course of one year duration with annual intake of 100 students vide Order No. NRC/NCTE/F-3/PB-258/9324-9333 dated 19.08.2005 and an additional intake of another 100 students followed by revised recognition order for two-year duration with annual intake 200 students from the academic session 2015-2016 vide Order No. NRC/NCTE/PB-258+NRCAPP-2822/2015/106963-67 dated 29.05.2015.


In view of the above, the Committee permitted as under:

Add. M.Ed., B.Ed. M.Ed. (3-year Integrated) & B.A.B.Ed./B.Sc. B.Ed. (4-year Integrated) course(s) {already transited into ITEP}.
