**WITHDRAWAL ORDER**

WHEREAS the recognition was granted to the institution namely **Sarvajanik Mahavidyalaya, Post-Mungra Badshahpur, Jaunpur-222202, Uttar Pradesh** for conducting B.Ed. course of one-year duration with an annual intake of 100 students vide order No. NRC/NCTE/F-3/UP1684/8998-8957 dated **12.08.2005** followed by revised recognition order for B.Ed. course of two -year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order No. F.NO./NRC/NCTE/UP-1684/2015/103035-40 dated **23.05.2015**.

2. **AND WHEREAS**, the institution had not submitted the compliance of the conditions mentioned in the revised recognition order.

3. **AND WHEREAS**, as per decision of NRC taken by 281<sup>st</sup> Meeting held on 20<sup>th</sup> & 21<sup>st</sup> February, 2018, first show cause notice under Section 17 of NCTE Act, 1993 was issued to the institution vide letter No. NRC/NCTE/UP-16842018192024 dated 28.03.2018. The institution had not submitted reply of the first show cause notice dated 28.03.2018.

4. **AND WHEREAS**, the matter was placed before NRC in its 414<sup>th</sup> Meeting held on 06<sup>th</sup> & 07<sup>th</sup> October 2023, and the Committee decided that final show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution on the following grounds:-

- (i) *The institution is required to submit the latest Certified registered land documents issued by the Registering Authority.*
- (ii) *The institution is required to submit the Blueprint of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as classrooms etc. along with approval letter issued by concerned Govt. Authority.*
- (iii) *The institution is required to submit the Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.*
- (iv) *The institution is required to submit THE latest Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.*
- (v) *The institution is required to submit a certified copy of site plan with demarcated land area for running different courses.*
- (vi) *The institution is required to submit a Building Safety Certificate from the Competent Government Authority.*
- (vii) *The institution is required to submit a Fire Safety Certificate issued by the Competent Government Authority.*
- (viii) *The institution is required to submit a certificate to the effect that the building is differently abled friendly from the Competent Government Authority.*

- (ix) The institution is required to submit the Building Completion Certificate signed by the Competent Government Authority.
- (x) The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative and notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/ appointed faculty in the prescribed proforma.
- (xi) The institution is required to submit the details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- (xii) The institution is required to submit original valid Fixed Deposit Receipts maintained in Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly filled in Form "A" in original verified/ signed by the Manager of the Bank.
- (xiii) The institution is required to submit the downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- (xiv) The institution has not adhered to the mandatory disclosure and displayed up to date information on its official website as per Regulation 8(14) of the NCTE Regulations 2014.
- (xv) Status of NAAC.
- (xvi) A letter of complaint was received from Sh. Pankaj Kumar Singh against the institution. The institution was required to submit point-wise reply on the compliant.

5. **AND WHEREAS**, final show cause notice was issued to the institution on 12.10.2023. The institution had not submitted any reply of final show cause notice.

6. **AND WHEREAS**, the matter was placed before NRC in its 436<sup>th</sup> Meeting (Volume-1) held on 20<sup>th</sup> & 21<sup>st</sup> March 2025 and the Committee decided as under:-

*"The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee noted the following: -*

- The recognition was granted to the institution namely Sarvajanic Mahavidyalaya, Post – Mungra Badshahpur, Jaunpur – 222202, Uttar Pradesh for conducting B.Ed. course of one year duration with annual intake of 100 students vide order No. F.NRC/NCTE/F3/UP-1684/8998-8957 dated 12.08.2005 followed by revised recognition order for B.Ed. course of two year duration with an annual intake of 100 students vide order no. F. No./NRC/NCTE/UP-1684/2015/103035-40 dated 23.05.2015.
- The institution had not submitted the compliance of the conditions mentioned in the revised recognition order.

- *The institution had not submitted a reply to the First Show Cause Notice dated 28/03/2018.*
- *The matter was placed before NRC in its 414<sup>th</sup> Meeting held on 06<sup>th</sup> & 07<sup>th</sup> October 2023, and the Committee decided that Final Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution on the following grounds:-*

*The Committee considered the matter of the institution and observed the following:*

- *The institution has not submitted a reply of Final Show Cause Notice dated 12/10/2023.*

***Hence, the Committee decided that the recognition granted to the institution for offering B.Ed. course be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026."***

7. **NOW THEREFORE**, in exercise of the powers vested Under Section 17(1) of the NCTE Act, 1993, the Northern Regional Committee decided to withdraw the recognition of the institution namely **Sarvajanik Mahavidyalaya, Post-Mungra Badshahpur, Jaunpur-222202, Uttar Pradesh** for B.Ed. course with effect duration from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026.

8. Further, if the institution is not satisfied with the order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
