RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely **Sarvajanik Mahavidyalaya, Post – Mungra Badshahpur, Jaunpur – 222202, Uttar Pradesh** for B.Ed. course of one year duration with annual intake of 100 (Hundred) students vide order No. F.NRC/NCTE/F3/UP-1684/8998-8957 dated 12.08.2005 followed by revised recognition order for two year duration with an annual intake of 100 students from the academic session 2015-2016 vide order no. F. No./NRC/NCTE/UP-1684/2015/103035-40 dated 23.05.2015.

2. AND WHEREAS, as per decision of NRC taken in its 436th meeting (Volume-1) held on 20th & 21st March 2025 and the Committee decided to withdraw the recognition of the institution. Withdrawal order was issued to the institution on 06.05.2025.

3. AND WHEREAS, the institution filed an appeal under Section 18 of NCTE Act 1993 against withdrawal order dated 06.05.2025. The Appellate Authority passed an order dated 28.08.2025 remanding back the case to NRC with a direction to verify the documents submitted in appeal from the concerned affiliating University. The appellant institution is directed to forward to the NRC the document submitted an appeal with 15 days from the receipt of the order of the Appeal.

4. AND WHEREAS, the matter was placed before NRC in its 449th Meeting (Volume-2) held on 13th & 14th October, 2025 and the Committee considered the representation dated 09.10.2025 and decided as under:-

“The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- *The recognition was granted to the institution namely Sarvajanik Mahavidyalaya, Post – Mungra Badshahpur, Jaunpur – 222202, Uttar Pradesh for B.Ed. course of one year duration with annual intake of 100 (Hundred) students vide order No. F.NRC/NCTE/F3/UP-1684/8998-8957 dated 12.08.2005. and revised recognition order for B.Ed. two-year duration was issued to the institution vide order dated 23.05.2015.*
- *As per the decision of NRC taken in its 436th Meeting Volume-I held on 20th & 21st March 2025 Withdrawal Order was issued to the institution on 06.05.2025.*




- *The institution filed an appeal under section 18 of NCTE Act 1993 against withdrawal order dated 06.05.2025. The Appellate Authority passed an order dated 28.08.2025 remanding back the case to NRC with a direction to verify the documents submitted in appeal from the concerned affiliating university. The appellant institution is directed to forward to the NRC the document submitted in appeal within 15 days from the receipt of the order of the Appeal.*

The Committee consider the appeal order dated 28.08.2025 and decided to restore the recognition for B.Ed. course of two-year duration with an annual intake of 100 students to the institution namely, Sarvajanik Mahavidyalaya, Post – Mungra Badshahpur, Jaunpur – 222202, Uttar Pradesh.”

5. **NOW THEREFORE**, in view of the decision taken by NRC, the recognition granted to the institution namely **Sarvajanik Mahavidyalaya, Post – Mungra Badshahpur, Jaunpur – 222202, Uttar Pradesh** offering B.Ed. course of two year duration with an annual intake of 100 students i.e. two basic unit 50 students each is hereby restored.
