**Order for Change The Name of The Affiliating bod**

WHEREAS, the recognition was granted to the institution namely **Baba Ramdal Surajdev Smarak Mahavidyalaya, Plot No. 330 Mi, Village-Madhopur Taufirr (Pakwainar) P.O. Navapura, Tehsil/Taluka-Rasra, District-Balia-221706, Uttar Pradesh** for offering B.Ed. course two-year duration with an annual intake of 100 students vide Order No. NRC/NCTE/NRCAPP-5639/233<sup>rd</sup> Meeting/2015/90037-056 dated **03.03.2015**.
