ORDER: CHANGE THE NAME OF THE INSTITUTION

WHEREAS, recognition was granted to the institution namely **Shri Rajaram Degree College, Tariyari, Jai Gopal Ganj, Jaunpur, Uttar Pradesh** for offering B.Ed. course one-year duration with an annual intake of 60 students vide Order No. NRC/NCTE/F-3/UP-347/2000/9033-40 dated 09.08.2000 followed by revised recognition Order for offering B.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2015-2016 was issued to the institution vide Order No. NRC/NCTE/UP-347/2015/111163-68 dated 05.06.2015.

2. **AND WHEREAS**, revised recognition order was issued to the institution in the name of Shri Raja Degree College.

3. **AND WHEREAS**, the institution vide letter dated 23.02.2026 has requested the Northern Regional Committee to change the name of the institution from “**Shri Rajaram Degree, Tariyari, Jai Gopal Ganj, Jaunpur, Uttar Pradesh** to **Shri Rajaram Mahavidyalaya, Tariyari, Kerakat, Jaunpur, Uttar Pradesh.**”

4. **AND WHEREAS**, the matter was placed before NRC in its 462<sup>nd</sup> Meeting (Part-2) held on 16<sup>th</sup> & 17<sup>th</sup> April, 2026 and the Committee decided as under:-

*“The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:-*

- *Recognition was granted to the aforesaid institution for offering B.Ed. course of one year duration with an annual intake of 60 students vide Order No. NRC/NCTE/F-3/UP-347/2000/9033-40 dated 09.08.2000 followed by revised recognition order for B.Ed. Course for two-year duration with an annual intake of 50 students vide Order No. NRC/NCTE/UP-347/2015/111163-68 dated 05.06.2015.*

Course of two-year duration with an annual intake of 50 students.*

5. **NOW THEREFORE**, in terms of above decision of NRC change the name of the institution from "**Shri Raja Ram Degree, Tariyari, Jai Gopal Ganj, Jaunpur, Uttar Pradesh** to **Shri Rajaram Mahavidyalaya, Tariyari, Kerakat, Jaunpur, Uttar Pradesh.**" for offering B.Ed. course of two-year duration with an annual intake of 50 students.
