WHEREAS In terms of Section 14(1) of the NCTE Act, 1993 Sant Bhola Satyanam Das Birbal P.G. College, Vill- Amari, Post- Dullahapur, Tehsil- Jakhania, District- Ghazipur, U.P., has submitted an application (UP-2447) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed Course of one year duration with an annual intake of 100 (One Hundred only) students on 25.04.2008.

The Para (1) of the above mentioned order may be read as follows:-

"NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Sant Bhola Satyanam Das Birbal P.G. College, Vill- Amari, Post- Dullahapur, Tehsil- Jakhania, District- Ghazipur, U.P. for conducting B.P.Ed Additional Intake of Secondary (level) of one year duration with an annual intake of 100 (50 Existing + 50 Proposed= 100) (One Hundred Only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009."

Other contents of the order F.NRC/NCTE/F-7/UP-2447/150 Meeting/2009/11733-11739 dated 29.10.2009 will remain unchanged. The Corrigendum shall remain effective from the date of issue of the earlier order dated 29.10.2009.
