ORDER /91007-016

WHEREAS, in terms of Section 14(1)/15(1) of the NCTE Act, 1993, **Al-Falah School of Education & Training, Village-Dhauj, Distt. Faridabad-121004, Haryana** had submitted the applications to the Northern Regional Committee of NCTE for grant of recognition/permission for different teacher education courses and had been granted recognition/permission for conducting the said courses: -

1. Order No. F.NRC/NCTE/F-3/HR-275/3867-3876 dated 07.08.2006 for B.Ed. course with an annual intake of **100 (One Hundred Only)** students.
2. Order No. F.NRC/NCTE/F-7/HR-584/2007/29346-52 dated 29.09.2007 for B.Ed. (Additional Intake) with an annual intake of **100+100=200 (Two Hundred Only)** students.
3. Order No. NRC/NCTE/F-7/HR-1188/2008/56931-37 dated 18.08.2008 for B.Ed. (Additional Intake) with an annual intake of **Existing 200+Add. Intake 100=300 (Three Hundred only)** students.
4. Order No. NRC/NCTE/F-7/HR-1116/2008/60219-225 dated 03.09.2008 for M.Ed. course with an annual intake of **25 (Twenty Five only)** students.
5. Order No. F.NRC/NCTE/F-7/HR-583/2007/29619-29625 dated 03.10.2007 for D.Ed. (JBT) course of two years with an annual intake of **50 (Fifty only)** students.
6. Order No. F.NRC/NCTE/HR-1167/2008/55877-83 dated 12.08.2008 for D.Ed. (Additional Intake) with an annual intake of **50+50=100 (One Hundred only)** students.

AND, WHEREAS, a letter dated 14.05.2014 was received from Al-Falah Charitable Trust informing that Al-Falah School of Education & Training, Dhauj, Faridabad, Haryana which has been approved by NCTE is now a part of Al-Falah University. The admissions from the session 2014-15 will be done in Al-Falah University.

AND, WHEREAS, letter No. CB-XI/2014/20959 dated 13.08.2014 was received from Maharishi Dayanand University, Rohtak informing about dis-affiliation of Al-Falah School of Education and Training, Dhauj, Distt. - Faridabad, Haryana from M.D. University, Rohtak.

AND, WHEREAS, a letter dated 15.10.2014 was received from Al-Falah Charitable Trust requesting for replacement of name of M.D. University, Rohtak, Haryana with Al-Falah University, Faridabad, Haryana.

AND, WHEREAS, the matter was placed before the NRC in its 228th meeting held on 30.09.2014. The Committee decided as under: -

"The request of the University regarding change of name of the institution to Faculty of Education / School of Education will be considered after notification of the new regulations 2014 to be framed by NCTE by 30. 11.2014."

AND, WHEREAS, letter was issued to the Trust on 10.11.2014.

AND, WHEREAS, letter dt. 11.11.2014 was received from Al-Falah Charitable Trust in NRC office on 14.11.2014 informing that it never applied for change of name; rather it has applied for change of the name of the University.

AND, WHEREAS, the matter was placed before the NRC in its 231st meeting held on 21st to 24th January, 2015. The Committee decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observations was made.

No Objection Certificate from the State Government and the affiliating authorities (with which the courses are affiliated at present) be submitted."

AND, WHEREAS, the NRC while confirming the minutes of 231st meeting in 232nd meeting (1st sitting) held on 02nd to 06th February, 2015 decided as under: -

The decision mentioned against agenda item 231.38.1 be read as "Request of the university for change of affiliating university from MD University, Rohtak, Haryana to their own University i.e. Al-Falah University (Govt. Gazette Notification dt. May 2, 2014) is accepted. Necessary orders be issued accordingly."

NOW, THEREFORE, the name of the University is hereby replaced from Maharishi Dayanand University, Rohtak to Al-Falah University. The recognition/permission granted by the Northern Regional Committee of NCTE to Al-Falah School of Education & Training, Village-Dhauj, Distt. Faridabad-121004, Haryana for teacher education courses will now be conducted under Al-Falah University.
