**Order for Change the Name of Institution**

WHEREAS, recognition was granted to the institution namely **Basant Degree College, Village-Tendui, Post-Sarayinyat, District- Allahabad, State-Uttar Pradesh** for offering B.Ed. course one-year duration with an annual intake of 100 students from the academic session 2004-2005 vide Order No. NRC/NCTE/F-3/UP-959/5413 dated **05.08.2004** followed by revised recognition order for B.Ed. two-year duration with an annual intake of 100 students from the academic session 2015-2016 vide Order No. NRC/NCTE/UP-959/2015/103935-40 dated **25.05.2015**.

2. **AND WHEREAS**, the institution had not submitted compliance of revised recognition order dated 25.05.2015.

3. **AND WHEREAS**, as per decision taken by NRC, NCTE in its 441<sup>st</sup> Meeting held on 22.05.2025, the recognition for B.Ed. Course was withdrawn to the institution under Section 17 of NCTE Act, 1993. Accordingly, withdrawal order was issued to the institution vide Order No. NCTE/2025/NRC/PAR/ORDER/UP-959 dated 30.05.2025.

4. **AND WHEREAS**, the institution filed an appeal under Section 18 of the NCTE Act 1993 before the Council against withdrawal order dated 30.05.2025 and the Appellate Authority passed an Order dated 26.09.2025 remanded the case back to NRC with a direction to re-examine the submission of PAR by the institution and consider the documentary evidence furnished by it with the appeal in accordance with the provisions of the NCTE Regulations 2014 and guidelines issued from time to time.

5. **AND WHEREAS**, the matter was placed before NRC in its 449<sup>th</sup> meeting (volume-2) held on 13<sup>th</sup> & 14<sup>th</sup> October 2025 and the Committee decided to restore the recognition for B.Ed. course. Accordingly, restoration order was issued to the institution on 05.01.2026.

6. **AND WHEREAS**, the institution has submitted a representation dated 20.02.2026 to the office of NRC requesting to change the name of the institution from **“Basant Degree College** to **“Basant Mahavidyalaya”** at Village Tendui, Post-Sarayinyat, District- Allahabad, Uttar Pradesh.

7. **AND WHEREAS**, the matter was placed before NRC in its 461<sup>st</sup> Meeting (Volume-2) held on 24<sup>th</sup> & 25<sup>th</sup> March, 2026 and the Committee decided as under:-

*“The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:*

- ❖ *Recognition was granted to the aforesaid institution for offering B.Ed. course of one year duration with annual intake of 100 students from the academic session 2004-2005 vide Order No. NRC/NCTE/F-3/UP-959/5413 dated **05.08.2004** followed by revised recognition order for two-year duration with annual intake 100 students from the academic session 2015-2016 vide Order No. NRC/NCTE/UP-959/2015/103935-40 dated **25.05.2015**.*
- ❖ *The institution has not submitted reply of compliance of revised recognition order.*
- ❖ *Recognition of the institution was withdrawn by NRC vide Order No. NCTE/2025/NRC/PAR/ORDER/UP-959 dated 30.05.2025.*
- ❖ *The institution filed an appeal under Section 18 of the NCTE Act 1993 before the Council and the Appellate Authority vide its Order dated 26.09.2025 remanded the case back to NRC with a direction to re-examine the submission of PAR by the institution and consider the documentary evidence furnished by it with the appeal in accordance with the provisions of the NCTE Regulations 2014 and guidelines issued from time to time.*
- ❖ *As per the decision taken by NRC in its 449<sup>th</sup> Meeting (Volume-2) held on 13<sup>th</sup> & 14<sup>th</sup> October 2025, Restoration Order & Show Cause Notice was issued to the institution on 05.01.2026. The institution has not submitted a reply of Show Cause Notice.*
- ❖ *The institution vide letter dated 20.02.2026 has requested the Northern Regional Committee to change the name of the institution from “Basant Degree College” to “Basant Mahavidyalaya”.*

***In view of the above, the Committee considered the matter and decided that the name of the institution be changed from “Basant Degree College” to “Basant Mahavidyalaya” at Village Tendui, Post Sarayinyat, District Allahabad, Uttar Pradesh for offering its B.Ed. Course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each.***

***Orders be issued accordingly.”***

8. **NOW THEREFORE**, in terms of above decision of NRC, the institution namely **Basant Degree College, Village-Tendui, Post-Sarayinyat, District- Allahabad, State-Uttar Pradesh** is hereby permitted to change its name from **Basant Degree College, Village-Tendui, Post-Sarayinyat, District- Allahabad, State-Uttar Pradesh** to **Basant Mahavidyalaya, Village-Tendui, Post-Sarayinyat, District- Allahabad, State-Uttar Pradesh** for offering B.Ed. course of two-year duration with an annual intake of 100 students.
