ORDER

WHEREAS in term of section 14(1) of the NCTE Act, 1993 **Jai Durge College Of Education, Vill-Saidpur, Post- Baldeo, Tehsil- Mahavan, District- Mathura, U.P** had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.ED course of one year duration with an annual intake of 100 (one hundred only) students on 20.08.2008.

AND WHEREAS, the application was processed and the Inspection of the said institution under section 14 was conducted by visiting team on 24.06.2009. The report of the visiting team was considered by NRC in its 144th meeting held from July 12-14, 2009 and NRC decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 22.07.2009 on certain grounds.

AND WHEREAS, the reply submitted by the institution in response to the points of show cause notice, was considered by the NRC in its 146th meeting held from August 5-7, 2009 and NRC decided that VT to verify the claims made by the Institution in its reply.

AND WHEREAS, the VT Expert submitted the report of the inspection in this matter, was considered by the NRC in its 157th meeting held from March 24-27, 2010 and NRC decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 31.03.2010 on certain grounds.

AND WHEREAS, the reply submitted by the institution in response to the points of show cause notice, was considered by the NRC in its 161st meeting held from May 26-29, 2010 and NRC decided to send the VT to verify the deficiencies met. Accordingly, letter was issued to the institution for re- inspection on 23.07.2010.

AND WHEREAS, the re- inspection of the institution u/s 14 was conducted on 30.07.2010. The VTR was considered by the NRC in its 165th meeting held on September 1-2, 2010 and NRC decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 10.09.2010 on certain grounds.

AND WHEREAS, the reply submitted by the institution in response to the points of show cause notice, was considered by the NRC in its 174th meeting held from December 8-10, 2010 and NRC found the reply satisfactory and decided to issue letter under clause 7(9) of NCTE Regulation. Accordingly, letter under clause 7(9) was issued to the institution on 17.01.2011.

AND WHEREAS, the reply submitted by the institution in response to letter under clause 7(9), was considered by the NRC in its 182nd meeting held from May 15-21, 2011 and NRC decided that the institution be asked to submit a copy of the University's approval to the appointments of Principal/Lecturer.

AND WHEREAS, the reply submitted by the institution in response to decision of 182nd meeting of NRC, was considered by the NRC in its 183rd (2nd Setting) meeting held from June 8-14, 2011, and NRC decided that **Formal recognition Under Clause 7(11) of the NCTE Regulations be issued for 100 seats of B.ED. Course from the academic session 2011-12.**

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(b) of the NCTE Act, 1993, the Northern Regional Committee hereby grants the recognition to **Jai Durge College Of Education, Vill- Saidpur, Post- Baldeo, Tehsil- Mahavan, District- Mathura, U.P** for **B.ED Course with an intake of 100 (one hundred only) seats under clause 7(11) of NCTE Regulation 2009 from the academic session 2011-12 subject to the following conditions:-**

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
